1           WHEREAS, The certain knowledge of a life well lived may help  
2 comfort the family and many friends of Richard Alan Perkins of  
3 Dallas, who passed away on February 26, 2015, at the age of 66; and

4           WHEREAS, Richard Perkins was born in Dallas on July 4, 1948,  
5 to George and Effie Perkins; he earned the rank of Eagle Scout at  
6 the age of 13 and graduated from Bryan Adams High School in 1966;  
7 from 1968-1970, he served in the United States Marine Corps,  
8 volunteering for a tour of duty in Vietnam in 1969; after he was  
9 honorably discharged as a sergeant, he went on to earn an  
10 associate's degree from Eastfield College and a bachelor's degree  
11 from Amberton University; and

12           WHEREAS, Mr. Perkins began his professional career in  
13 environmental health and safety, working for Western Electric and  
14 Southwestern Bell; he later became a manager for Dallas Area Rapid  
15 Transit before starting his own business remodeling homes; and

16           WHEREAS, In addition to his professional accomplishments,  
17 Mr. Perkins devoted countless hours to support the causes he  
18 believed in; a lifelong advocate for working men and women, he was  
19 an officer with the Communications Workers of America, and Governor  
20 Ann Richards appointed him to one of three seats on the Texas  
21 Industrial Accident Board; and

22           WHEREAS, Active in Democratic politics, Mr. Perkins helped  
23 with many local and state campaigns, and he distinguished himself  
24 as secretary of the Texas Democratic Party from 1978 to 1982; party

1 leaders in Dallas chose him to introduce presidential candidate  
2 Barack Obama at an area rally in 2008, and Mr. Perkins remained  
3 enthusiastically involved in politics, even during the last months  
4 of his life as he battled cancer; and

5 WHEREAS, Admired for his humor, generosity, and dedication,  
6 Richard Perkins gave freely of his time and expertise to help  
7 others, and he leaves behind a record of service that his loved ones  
8 can remember with pride; now, therefore, be it

9 RESOLVED, That the House of Representatives of the 84th Texas  
10 Legislature hereby pay tribute to the memory of Richard Alan  
11 Perkins and extend heartfelt sympathy to the members of his family:  
12 to his children, Ashley Berkowski and her husband, Dustyn, and  
13 Lindsay Jedlowski and her husband, Steven; to his grandchildren,  
14 Kendal, Jacey, Owen, Colton, and Avery; to his siblings, Don  
15 Perkins and his wife, Mary, and Carol Logan; and to his other  
16 relatives and friends; and, be it further
