## RESOLUTION

1 WHEREAS, Austin residents lost an esteemed community leader

with the passing of Andrew Reyes Ramirez on April 17, 2015, at the

WHEREAS, The son of David and Oralia Ramirez, Andy Ramirez

5 was born in Austin on February 13, 1942; he was raised by his mother

6 in the tight-knit Mexican American community on the city's East

7 Side while his father served in the military during World War II; as

8 a boy, he worked long hours shining shoes, but he still succeeded in

9 making straight A's; in 1961, he married Nellie Ancira, and they

10 became the parents of twins, Andrew and Annette; and

11 WHEREAS, Mr. Ramirez worked at the Glastron Boat Factory

before serving his country in the United States Navy; subsequently,

13 he majored in math at The University of Texas at Austin, where he

14 became acutely aware of discrimination against Mexican Americans;

15 in the course of helping his parents run the Chuck Wagon Barbecue,

16 he met many political leaders, and he developed strong loyalties to

17 both the Mexican American and African American communities; and

18 WHEREAS, Determined to advance social justice, Mr. Ramirez

19 became one of the organizers of the historic Economy Furniture

20 strike; he then joined the staff of the governor's office to provide

21 technical assistance and oversight to War on Poverty Community

22 Action programs in South Texas; later, he was appointed to

23 supervise the Austin Community Action Agency, and when it was

24 incorporated into city government, he became Austin's director of

- 1 human development programs; he administered antipoverty projects
- 2 as well as initiatives in manpower development, economic
- 3 development, and juvenile justice, and he secured millions of
- 4 dollars in grants to benefit his fellow citizens; moreover, he
- 5 increased the employment of minorities and women, and he was
- 6 involved in such organizations as the National League of Cities;
- 7 and
- 8 WHEREAS, In the early 1970s, Mr. Ramirez urged his friend,
- 9 Buddy Ruiz, to run for the city council, and together, they waged a
- 10 spirited campaign that helped energize political activism among
- 11 Mexican Americans; Mr. Ramirez married Dr. Blandina Cardenas in
- 12 1978, and while she served in the Carter administration, he studied
- 13 public administration and policy at George Washington University;
- 14 after helping to found the National Hispanic Housing Coalition, he
- 15 served as its assistant director; he also gave generously of his
- 16 time, talents, and resources to Democratic candidates for office at
- 17 all levels; and
- WHEREAS, Mr. Ramirez worked in nonprofit development for
- 19 Solar America, an alternative energy company, before transitioning
- 20 to the private sector; as a founder of the Avante Corporation, he
- 21 engaged in commercial real estate development in San Antonio and
- 22 Austin; he went on to establish several companies, including Rz and
- 23 Associates and Rz Communications, and he was active in the U.S.
- 24 Hispanic Contractors Association de Austin and the Greater Austin
- 25 Hispanic Chamber of Commerce; in 1995, he received the Lifetime
- 26 Achievement Award from the chamber, and five years later, he was
- 27 named a special advisor to the governor of Texas; and

- 1 WHEREAS, Committed to expanding opportunity in Austin, he
- 2 mentored dozens of aspiring entrepreneurs, and he counseled young
- 3 Latinos seeking to start nonprofit organizations; in 2010, he
- 4 founded the Bellas Artes Alliance to promote Latino arts and
- 5 culture; with his wife, Linda Wolf Ramirez, he sponsored the
- 6 popular annual Pan Americana Festival, which the alliance produced
- 7 in cooperation with the city and the Emma S. Barrientos Mexican
- 8 American Cultural Center; and
- 9 WHEREAS, Andrew Ramirez devoted himself wholeheartedly to
- 10 making Austin a more equitable and inclusive place, and his life
- 11 stands as an inspiring example of positive civic engagement; now,
- 12 therefore, be it
- RESOLVED, That the House of Representatives of the 84th Texas
- 14 Legislature hereby pay tribute to the memory of Andrew Reyes
- 15 Ramirez and extend sincere sympathy to the members of his family: to
- 16 his wife, Linda Wolf Ramirez; to his children, Dorothy Lopez,
- 17 Andrew Ramirez Jr. and his wife, Sara, Annette Kjar and her husband,
- 18 Michael, and Alexandro Rudolpho Ramirez; to his stepdaughter,
- 19 Avelon Pang; to his brothers, David Ramirez and Robert Loera; to his
- 20 sisters, Yolanda Blanco and Mary Jane Haros; to his grandchildren
- 21 and great-grandchildren; and to his many other relatives and
