1           WHEREAS, Deanna Zimmerman is retiring from the office of  
2 State Representative Bill Zedler in 2015, concluding 27 years of  
3 distinguished service to the Texas Legislature; and

4           WHEREAS, For more than seven years, Ms. Zimmerman has  
5 provided invaluable support to Representative Zedler as his  
6 district director and chief of staff; she began her career in the  
7 office of State Representative Kent Grusendorf in 1988, and she  
8 first joined the staff of Representative Zedler in 2006; for one  
9 legislative session, she was employed in the office of  
10 Representative Linda Harper-Brown, and she then returned to  
11 Representative Zedler's staff; and

12           WHEREAS, Ms. Zimmerman has also made a positive difference in  
13 her community through her civic leadership; she has served the  
14 Arlington Chamber of Commerce as a two-term member of the  
15 Governmental Affairs Committee and as an ex-officio member of the  
16 Public Policy Advisory Committee; active in the Republican Party,  
17 she served two terms as scholarship chair for the Texas Federation  
18 of Republican Women, and she was a founding member of the Reagan  
19 Legacy Republican Women; moreover, she was named the 2000 Volunteer  
20 of the Year by the Tarrant County Republican Party State District  
21 10; and

22           WHEREAS, In all her endeavors, Ms. Zimmerman has enjoyed the  
23 love and support of her husband of 32 years, John Zimmerman, their  
24 children, John Clark, Gregory, and Justin, and their grandchildren,

1 Ravin, Kailey, Payton, Paul, J.C., Garrett, and J.C.; following  
2 Ms. Zimmerman's retirement, she and her husband are moving to  
3 Whitesboro, where they plan to raise cattle; the couple are also  
4 looking forward to taking long trips in their new travel trailer;

6 WHEREAS, Deanna Zimmerman has greatly benefited her fellow  
7 citizens over the course of more than a quarter-century in state  
8 government, and she may indeed reflect with pride on her  
9 accomplishments as she embarks on the next exciting chapter of her
