- BE IT RESOLVED by the House of Representatives of the State of

- 4 Section 9(f), to enable the conference committee appointed to

- 8 assault offenses) to consider and take action on the following

- House Rule 13, Section 9(a)(4), is suspended to permit the
- 11 committee to add text on a matter which is not included in either
- 12 the house or senate version of the bill by adding the following new
- 13 SECTIONS to the bill:
- 14 SECTION 1. Section 16.0045, Civil Practice and Remedies
- 15 Code, is amended to read as follows:
- 16 Sec. 16.0045. [FIVE-YEAR] LIMITATIONS PERIOD FOR CLAIMS
- 17 ARISING FROM CERTAIN OFFENSES. (a) A person must bring suit for
- 18 personal injury not later than 15 [five] years after the day the
- 19 cause of action accrues if the injury arises as a result of conduct
- 20 that violates:
- 21 (1) Section 22.011(a)(2) [22.011], Penal Code (sexual
- 22 assault of a child);
- 23 (2) Section 22.021(a)(1)(B) [22.021], Penal Code
- 24 (aggravated sexual assault of a child);

- 3 (4) Section 20A.02(a)(7)(A), (B), (C), (D), or (H) or

- 5 by Section 20A.02(a)(7)(A), (B), (C), (D), or (H) or sexual conduct
- 6 with a child trafficked in the manner described by Section

- 1 tolled for a suit on the filing of a petition by any person in an
- 2 appropriate court alleging that the identity of the defendant in
- 3 the suit is unknown and designating the unknown defendant as "John
- 4 or Jane Doe." The person filing the petition shall proceed with due
- 5 diligence to discover the identity of the defendant and amend the
- 6 petition by substituting the real name of the defendant for "John or
- 7 Jane Doe" not later than the 30th day after the date that the
- 8 defendant is identified to the plaintiff. The limitations period
- 9 begins running again on the date that the petition is amended.
- 10 SECTION 3. Section 16.0045, Civil Practice and Remedies
- 11 Code, as amended by this Act, applies only to a cause of action that
- 12 accrues on or after the effective date of this Act. A cause of
- 13 action that accrued before the effective date of this Act is
- 14 governed by the law applicable to the cause of action immediately
- 15 before the effective date of this Act, and that law is continued in
- 16 effect for that purpose.
- 17 Explanation: This addition is necessary to change the
- 18 statute of limitations for a suit for personal injury arising from
- 19 certain offenses constituting sexual abuse of a child.
