1 WHEREAS, Admired attorney and civic leader Robert Wayne 2 Strauser of Austin passed away on May 21, 2015, at the age of 71, only 12 days before the end of his 19th legislative regular session 3 at the Texas Capitol; and 4 5 WHEREAS, The son of Christopher "Pete" Strauser and Opal Orr Strauser, Bob Strauser was born in Little Rock, Arkansas, on August 6 7 8, 1943; he graduated from Davidson College and The University of Texas School of Law, and in 1968, he was hired by the Texas 8 9 Legislative Council as a drafting attorney; subsequently, he served as general counsel to the House Judiciary Committee, and in 1974, he 10 11 was recruited to form the Texas Association of Taxpayers; after 10 12 years, he joined the firm of Baker Botts L.L.P., and although he retired in 2008, he continued to represent clients before the 13 14 legislature until a week before his death; he was very proud to have served for many years in the Judge Advocate General's Corps of the 15 16 United States Navy Reserve, attaining the rank of captain; and WHEREAS, Mr. Strauser shared a fulfilling relationship with 17 his wife, Terri Seales, and he found great joy in raising his 18 children, Ben and Ann; he coached their soccer teams, and he was 19 20 happy to include their friends in family activities, achieving 21 recognition as "the cool dad"; in addition, he served on the board of the Big Brothers Little League teams of East Austin; he was a 22 23 tireless supporter of the Austin Symphony Orchestra and a longtime member of its board and executive committee, and he also served on 24
