1 BE IT RESOLVED by the House of Representatives of the State of 2 Texas, 84th Legislature, Regular Session, 2015, That House Rule 13, Section 9(a), be suspended in part as provided by House Rule 13, 3 Section 9(f), to enable the conference committee appointed to 4 5 resolve the differences on House Bill 2968 (preservation of the Alamo complex and surrounding area and to the Alamo Preservation 6 Advisory Board) to consider and take action on the following 7 matter: 8 House Rule 13, Section 9(a)(4), is suspended to permit the 9 committee to add text on a matter not included in either the house 10 11 or senate version of the bill by adding, in proposed SECTION 2 of 12 the bill, Section 31.455(b), Natural Resources Code, as follows: 13 The advisory board is composed of: 14 (1) the commissioner or the commissioner's designee, who serves as the presiding officer of the advisory board; 15 16 a designee appointed by the governor; a representative of the Alamo Endowment, appointed 17 (3) by the commissioner [the president general of the Daughters of the 18 Republic of Texas]; 19 20 (4) the director of the Alamo [current 21 chairperson of the Daughters of the Republic of Texas];
