- 1 WHEREAS, The death of Paul E. Glaske of Flint on January 30,
- 2 2015, at the age of 81, brought a great loss to his family, his
- 3 friends, and the LeTourneau University community; and
- WHEREAS, Born in Benton Harbor, Michigan, on August 31, 1933,
- 5 Paul Glaske earned his bachelor's degree at Bob Jones University;
- 6 after completing his master's degree in business at Pepperdine
- 7 University, he began his career with Standard Oil; and
- 8 WHEREAS, Mr. Glaske joined LeTourneau University as business
- 9 manager in 1963, and he was later appointed vice president for
- 10 business affairs; in 1968, he was named vice president of
- 11 administration of R. G. LeTourneau Incorporated, and three years
- 12 later, he became president of the Longview division of Marathon
- 13 LeTourneau Company; he was CEO and chair of the Blue Bird
- 14 Corporation of Fort Valley, Georgia, from 1986 until his retirement
- 15 in 1999; and
- 16 WHEREAS, Through the years, Mr. Glaske continued to give
- 17 generously of his time and expertise for the benefit of LeTourneau
- 18 University; he began serving on its board of trustees in 1975, and
- 19 he was chair from 1988 to 1999; subsequently, he served as
- 20 treasurer, as chair of the LETU Presidential Search Committee, and
- 21 as a member of the Trustee Committee for the Strategic Plan; in
- 22 2011, he was executive chair of the university's \$27.5 million "For
- 23 Such A Time As This" fund-raising campaign; and
- 24 WHEREAS, The university named the Paul E. Glaske Center for

- 1 Engineering, Science, and Technology in his honor, and it further
- 2 recognized his tremendous contributions with an honorary Doctor of
- 3 Laws degree and with the 2007 Henry O. Gossett Jr. Community Partner
- 4 Award; and
- 5 WHEREAS, Deeply committed to civic life, Mr. Glaske also
- 6 served as chair of the Good Shepherd Medical Center Board, as
- 7 president of the Longview Chamber of Commerce, and as chair of the
- 8 Texas Association of Business; he was a member of the board of the
- 9 Texas Association of Taxpayers and the Governor's State Job
- 10 Training Coordinating Council, and he served numerous other
- 11 organizations, including the YMCA, Pine Cove Christian Camps, the
- 12 Civitan Club, and United Way; and
- WHEREAS, In all his endeavors, he enjoyed the love and
- 14 support of his wife, Jacqueline, and their children, Randall,
- 15 Laura, and Caryn; and
- WHEREAS, An engaged citizen, a devoted family man, and an
- 17 admired business leader, Paul Glaske helped shape the destiny of
- 18 LeTourneau University while setting an example of faith and
- 19 selfless dedication that will continue to inspire its students in
- 20 the years to come; now, therefore, be it
- 21 RESOLVED, That the House of Representatives of the 84th Texas
- 22 Legislature hereby pay tribute to the life of Paul Edward Glaske and
- 23 extend sincere condolences to the members of his family: to his
- 24 wife, Jacqueline Glaske; to his children, Randall Glaske and his
