- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 1001.201, Health and Safety Code, as
- 6 added by Chapter 1306 (H.B. 3793), Acts of the 83rd Legislature,
- 7 Regular Session, 2013, is amended by adding Subdivisions (4) and
- 8 (5) to read as follows:
- 9 (4) "School district employee" means a person employed
- 10 by a school district who regularly interacts with students through
- 11 the course of the person's duties, including an educator, a
- 12 secretary, a school bus driver, or a cafeteria worker.
- 13 (5) "School resource officer" has the meaning assigned
- 14 by Section 1701.601, Occupations Code.
- 15 SECTION 2. Subchapter H, Chapter 1001, Health and Safety
- 16 Code, as added by Chapter 1306 (H.B. 3793), Acts of the 83rd
- 17 Legislature, Regular Session, 2013, is amended by adding Section
- 18 1001.2015 to read as follows:
- 19 Sec. 1001.2015. LIMITATION ON GRANTS. For each state
- 20 fiscal year, the department may give to a local mental health
- 21 authority in the form of grants under Sections 1001.202 and
- 22 1001.203 an amount that may not exceed the lesser of:
- 23 (1) three percent of the total amount appropriated to
- 24 the department for making grants under those sections; or

- 1 (2) \$70,000.
- 2 SECTION 3. Section 1001.202(b), Health and Safety Code, as
- 3 added by Chapter 1306 (H.B. 3793), Acts of the 83rd Legislature,
- 4 Regular Session, 2013, is amended to read as follows:
- 5 (b) The [Except as provided by Subsection (c), the]
- 6 department shall make each grant to a local mental health authority
- 7 under this section in an amount equal to \$1,000 times the number of
- 8 employees or contractors of the authority whose training as mental
- 9 health first aid trainers will be paid by the grant.
- SECTION 4. Sections 1001.203(a) and (c), Health and Safety
- 11 Code, as added by Chapter 1306 (H.B. 3793), Acts of the 83rd
- 12 Legislature, Regular Session, 2013, are amended to read as follows:
- 13 (a) To the extent funds are appropriated to the department
- 14 for that purpose, the department shall make grants to local mental
- 15 health authorities to provide an approved mental health first aid
- 16 training program, administered by mental health first aid trainers,
- 17 at no cost to school district employees and school resource
- 18 officers [educators].
- 19 (c) The [Subject to the limit provided by Subsection (b),
- 20 out of the funds appropriated to the department for making grants
- 21 under this section, the] department shall grant \$100 to a local
- 22 mental health authority for each <u>school district employee or school</u>
- 23 resource officer [educator] who successfully completes a mental
- 24 health first aid training program provided by the authority under
- 25 this section.
- SECTION 5. Subchapter H, Chapter 1001, Health and Safety
- 27 Code, as added by Chapter 1306 (H.B. 3793), Acts of the 83rd

- 1 Legislature, Regular Session, 2013, is amended by adding Section
- 2 1001.2031 to read as follows:
- 3 Sec. 1001.2031. SUPPLEMENTAL GRANTS FOR TRAINING CERTAIN
- 4 EDUCATORS IN MENTAL HEALTH FIRST AID. For each state fiscal year,
- 5 the department may allocate any unobligated money appropriated for
- 6 making grants under Sections 1001.202 and 1001.203 for supplemental
- 7 grants. The department may give a supplemental grant to a local
- 8 mental health authority that submits to the department a revised
- 9 plan as provided under Section 1001.204 that demonstrates how the
- 10 additional grant money would be used if made available to the
- 11 <u>authority</u>.
- 12 SECTION 6. Section 1001.204(a), Health and Safety Code, as
- 13 added by Chapter 1306 (H.B. 3793), Acts of the 83rd Legislature,
- 14 Regular Session, 2013, is amended to read as follows:
- 15 (a) Not later than July [October] 1 of each state fiscal
- 16 year for which a local mental health authority will seek a grant
- 17 from the department under Section 1001.203, the authority shall
- 18 submit to the department a plan demonstrating the manner in which
- 19 grants made to the authority under that section will be used:
- 20 (1) to train individuals in mental health first aid
- 21 throughout the authority's local service area to maximize the
- 22 number of children who have direct contact with an individual who
- 23 has successfully completed a mental health first aid training
- 24 program provided by the authority;
- 25 (2) to meet the greatest needs of the authority's local
- 26 service area, as identified by the authority; and
- 27 (3) to complement existing resources and not duplicate

- 1 established mental health first aid training efforts.
- 2 SECTION 7. Section 1001.205, Health and Safety Code, as
- 3 added by Chapter 1306 (H.B. 3793), Acts of the 83rd Legislature,
- 4 Regular Session, 2013, is amended to read as follows:
- 5 Sec. 1001.205. REPORTS. (a) Not later than <u>September 30</u>
- 6 [July 1] of each year, a local mental health authority shall provide
- 7 to the department the number of:
- 8 (1) employees and contractors of the authority who
- 9 were trained as mental health first aid trainers under Section
- 10 1001.202 during the preceding fiscal year;
- 11 (2) educators, school district employees other than
- 12 <u>educators</u>, and <u>school resource officers</u> who completed a mental
- 13 health first aid training program offered by the authority under
- 14 Section 1001.203 during the preceding fiscal [calendar] year; and
- 15 (3) individuals who are not school district employees
- 16 <u>or school resource officers</u> [<u>educators</u>] who completed a mental
- 17 health first aid training program offered by the authority during
- 18 the preceding fiscal [calendar] year.
- 19 (b) Not later than December 1 [August 1] of each year, the
- 20 department shall compile the information submitted by local mental
- 21 health authorities as required by Subsection (a) and submit a
- 22 report to the legislature containing the number of:
- 23 (1) authority employees and contractors trained as
- 24 mental health first aid trainers during the preceding fiscal year;
- 25 (2) educators, school district employees other than
- 26 <u>educators</u>, and <u>school resource officers</u> who completed a mental
- 27 health first aid training program provided by an authority during

- 1 the preceding fiscal [calendar] year; and
- 2 (3) individuals who are not <u>school district employees</u>
- 3 <u>or school resource officers</u> [<u>educators</u>] who completed a mental
- 4 health first aid training program provided by an authority during
- 5 the preceding fiscal [calendar] year.
- 6 SECTION 8. The following are repealed:
- 7 (1) Section 1001.202(c), Health and Safety Code, as
- 8 added by Chapter 1306 (H.B. 3793), Acts of the 83rd Legislature,
- 9 Regular Session, 2013; and
- 10 (2) Section 1001.203(b), Health and Safety Code, as
- 11 added by Chapter 1306 (H.B. 3793), Acts of the 83rd Legislature,
- 12 Regular Session, 2013.
- 13 SECTION 9. This Act takes effect immediately if it receives
- 14 a vote of two-thirds of all the members elected to each house, as
- 15 provided by Section 39, Article III, Texas Constitution. If this
- 16 Act does not receive the vote necessary for immediate effect, this
- 17 Act takes effect September 1, 2015.
