9	SECRETARY OF STATE WEBSITE. (a) A county may adopt a method of
10	appointment for volunteer deputy registrars prescribed by the
11	secretary of state or developed by the county and approved by the
12	secretary of state under this section that provides for the
13	training and examination of potential volunteer deputy registrars.
14	(b) For the purposes of this section, the secretary of state
15	shall:
16	(1) provide on the secretary of state's website the
17	training materials prescribed by the secretary of state under
18	Section 13.047 for volunteer deputy registrars; and
19	(2) prescribe and make available on the secretary of
20	state's website an examination based on those materials.
21	(c) A county that has adopted the method under this section:
22	(1) shall administer the required examination to a
23	potential volunteer deputy registrar at any time during the county
24	voter registrar's regular business hours; and

1 (2) is not required to hold in-person training 2 sessions for potential volunteer deputy registrars. 3 (d) At the time a person satisfactorily completes the examination in compliance with standards adopted by the secretary 4 of state, the registrar shall appoint the person as a volunteer 5 deputy registrar and advise the person: 6 7 (1) of county-specific procedures for processing voter registration applications, if applicable; and 8 (2) that the only requirements for voter registration 9 10 are those prescribed by state law or by the secretary of state. SECTION 2. This Act takes effect immediately if it receives 11 a vote of two-thirds of all the members elected to each house, as 12 provided by Section 39, Article III, Texas Constitution. If this 13 Act does not receive the vote necessary for immediate effect, this 14 15 Act takes effect September 1, 2015.
