A BILL TO BE ENTITLED

1 AN ACT 2 relating to the use of public school counselors' work time. 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Section 33.006, Education Code, is amended by 4 5 adding Subsections (c) and (d) to read as follows: 6 (c) In accordance with rules adopted by the commissioner, the board of trustees of each school district shall adopt a policy 7 that requires a school counselor to spend not more than 10 percent 8 9 of the school counselor's total work time on duties that are not components of a counseling or guidance program developed under 10 Section 33.005. For purposes of this subsection, time spent in 11 administering assessment instruments or providing other assistance 12 in connection with assessment instruments, except time spent in 13 14 interpreting data from assessment instruments, is not considered time spent on counseling or guidance. Each school in the district 15 shall implement the policy. A copy of the policy shall be 16 maintained in the office of each school in the district and made 17 available on request during regular school hours to district 18 19 employees, parents of district students, and the public. (d) A school district may not include a provision in an 20 employment contract with a school counselor under Chapter 21 that 21 conflicts with the policy required by Subsection (c) or has the 22

effect of authorizing a school principal or school district

superintendent to require a school counselor to generally perform

- 1 duties that are not primarily related to a counseling or guidance
- 2 function.
- 3 SECTION 2. Section 39.056, Education Code, is amended by
- 4 adding Subsection (d-1) to read as follows:
- 5 (d-1) Before an investigation, the commissioner shall
- 6 request that the school district scheduled for the investigation
- 7 assess the district's compliance with the policy adopted under
- 8 Section 33.006(c) and provide a written copy of the assessment to
- 9 the investigators on or before the date specified by the
- 10 commissioner. As part of each investigation, the investigators
- 11 shall interview a percentage of district school counselors
- 12 determined by the commissioner to assess the district's compliance
- 13 with the policy adopted under Section 33.006(c). The commissioner
- 14 shall adopt rules to implement this subsection.
- 15 SECTION 3. (a) Each school district shall implement a
- 16 policy adopted under Section 33.006(c), Education Code, as added by
- 17 this Act, beginning with the 2015-2016 school year.
- 18 (b) Section 33.006(d), Education Code, as added by this Act,
- 19 applies only to a contract executed on or after the effective date
- 20 of this Act. A contract executed before the effective date of this
- 21 Act is governed by the law in effect on the date the contract was
- 22 executed, and the former law is continued in effect for that
- 23 purpose.
- 24 (c) Section 39.056(d-1), Education Code, as added by this
- 25 Act, applies beginning with the 2015-2016 school year.
- 26 SECTION 4. This Act takes effect immediately if it receives
- 27 a vote of two-thirds of all the members elected to each house, as

- 1 provided by Section 39, Article III, Texas Constitution. If this
- 2 Act does not receive the vote necessary for immediate effect, this
- 3 Act takes effect September 1, 2015.
