A BILL TO BE ENTITLED

1 AN ACT 2 relating to the continuation and functions of the Governor's 3 Committee on People with Disabilities. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4 SECTION 1. Section 115.005, Human Resources Code, 5 is amended to read as follows: 6 Sec. 115.005. SUNSET PROVISION. The Governor's Committee 7 on People with Disabilities is subject to Chapter 325, Government 8 Code (Texas Sunset Act). Unless continued in existence as provided 9 by that chapter, the committee is abolished and this chapter 10 expires September 1, 2027 [2015]. 11 SECTION 2. Section 115.009, Human Resources Code, 12 is 13 amended to read as follows: Sec. 115.009. FUNCTIONS. The committee shall: 14 (1) serve as a central source of information and 15 16 education on the abilities, rights, problems, and needs of persons with disabilities and, as necessary, issue reports; 17 18 (2) provide information to and advise the governor and the governor's staff on matters relating to the full participation 19 20 of persons with disabilities in all aspects of life; 21 (3) before the end of each even-numbered year, submit 22 to the governor and to the legislature a report that includes [+ 23 $[(\Lambda)$ the status of the state's compliance with federal and state laws pertaining to rights and opportunities for 24

This Act takes effect September 1, 2015.
