2-1 Act. That liability continues in effect as if this Act had not been 2-2 enacted, and the former law is continued in effect for the 2-3 collection of taxes due and for civil and criminal enforcement of 2-4 the liability for those taxes.

2-5 SECTION 4. Except as otherwise provided by this Act, this 2-6 Act takes effect immediately if it receives a vote of two-thirds of 2-7 all the members elected to each house, as provided by Section 39, 2-8 Article III, Texas Constitution. If this Act does not receive the 2-9 vote necessary for immediate effect, this Act takes effect 2-10 September 1, 2015.
