4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter A, Chapter 44, Education Code, is
6	amended by adding Section 44.012 to read as follows:

- 7 <u>Sec. 44.012. ANNUAL TRANSMISSION OF INFORMATION TO</u>
  8 <u>COMPTROLLER. The agency shall transmit annually an electronic copy</u>
- 9 of each school district's adopted budget and any school district
- 10 financial reports filed with and reviewed by the agency under
- 11 <u>Section 44.010</u> for purposes of providing the comptroller with
- 12 <u>information to operate and update the Political Subdivision Public</u>
- 13 <u>Information Warehouse under Section 403.0241, Government Code. The</u>
- 14 agency shall transmit the information in the form prescribed by the
- 15 comptroller.

- SECTION 2. Subchapter B, Chapter 403, Government Code, is
- 17 amended by adding Section 403.0241 to read as follows:
- 18 <u>Sec. 403.0241. POLITICAL SUBDIVISION PUBLIC INFORMATION</u>
- 19 WAREHOUSE. (a) In this section, "tax year" has the meaning
- 20 assigned by Section 1.04, Tax Code.
- 21 (b) The comptroller shall create and make accessible on the
- 22 <u>Internet a database, to be known as the Political Subdivision</u>
- 23 Public Information Warehouse, that contains information regarding
- 24 all active political subdivisions of this state that are authorized

- 1 by the state by a general or special law to impose an ad valorem or
- 2 sales and use tax or to issue bonds, notes, or other obligations.
- 3 (c) The warehouse database must include with respect to each
- 4 political subdivision described by Subsection (b):
- 5 (1) the name of the political subdivision;
- 6 (2) the rate of any sales and use tax the political
- 7 <u>subdivision imposes;</u>
- 8 (3) the table of ad valorem tax rates for the most
- 9 recent tax year described by Section 26.16, Tax Code, in the form
- 10 required by that section;
- 11 (4) the total amount of the political subdivision's
- 12 debt, including principal and interest, and the year in which that
- 13 debt would be paid in accordance with the current applicable terms;
- 14 (5) the political subdivision's Internet website
- 15 address or, if the political subdivision does not operate an
- 16 Internet website, contact information to enable a member of the
- 17 public to obtain information from the political subdivision; and
- 18 (6) the Internet website address for the appraisal
- 19 district in each county in which the political subdivision has
- 20 territory.
- 21 (d) The warehouse database may include with respect to each
- 22 political subdivision described by Subsection (b) the following
- 23 <u>information</u>, or a link to the information, that is provided through
- 24 an Internet website maintained by the political subdivision:
- 25 (1) information describing the political
- 26 subdivision's boundaries;
- 27 (2) the political subdivision's budget for its current

- 1 fiscal year;
- 2 (3) each current check registry published by the
- 3 political subdivision's governing body; and
- 4 (4) any other current financial audit or annual report
- 5 published by the political subdivision's governing body.
- 6 (e) The comptroller may consult with the appropriate
- 7 officer of, or <u>other person representing</u>, each political
- 8 subdivision described by Subsection (b) to obtain the information
- 9 necessary to operate and update the warehouse database.
- 10 (f) The governing body of a political subdivision that
- 11 publishes on the political subdivision's Internet website the
- 12 political subdivision's check registry shall provide to the
- 13 comptroller the Internet address of the Internet page on which that
- 14 registry may be accessed for purposes of Subsection (d)(3).
- 15 (g) To the extent information required in the warehouse
- 16 <u>database is otherwise collected or maintained by a state agency or</u>
- 17 political subdivision, the comptroller may request and the state
- 18 agency or political subdivision shall provide that information and
- 19 updates to the information as necessary for inclusion in the
- 20 warehouse database.
- 21 (h) The comptroller shall update information in the
- 22 warehouse database regarding the rates of taxes imposed by each
- 23 political subdivision described by Subsection (b) at least
- 24 annually.
- 25 (i) To the extent possible, the comptroller shall present
- 26 information in the warehouse database in a manner that is
- 27 searchable and intuitive to users. The comptroller may enhance and

- 1 organize the presentation of the information through the use of
- 2 graphical representations as the comptroller considers
- 3 <u>appropriate</u>.
- 4 (j) The comptroller may not charge a fee to the public to
- 5 access the warehouse database.
- 6 (k) The comptroller may establish procedures and adopt
- 7 rules to implement this section.
- 8 SECTION 3. Chapter 203, Local Government Code, is amended
- 9 by adding Subchapter D to read as follows:
- 10 SUBCHAPTER D. RECORDS AND INFORMATION PROVIDED TO COMPTROLLER
- Sec. 203.061. APPLICABILITY OF SUBCHAPTER. (a) This
- 12 subchapter applies only to the following political subdivisions of
- 13 this state:
- 14 (1) each political subdivision that has authority to
- 15 issue general obligation bonds, except as provided by Subsection
- 16 (b), including a taxing unit as defined by Section 1.04, Tax Code,
- 17 that has authority to issue general obligation bonds; and
- 18 (2) each special purpose district or other political
- 19 subdivision that has authority to impose a sales tax, including a
- 20 taxing entity as defined by Section 322.002, Tax Code.
- 21 (b) This subchapter does not apply to a school district.
- Sec. 203.062. PROVISION OF CERTAIN RECORDS AND OTHER
- 23 INFORMATION TO COMPTROLLER. A political subdivision shall transmit
- 24 records and other information specified by this subchapter to the
- 25 comptroller annually for purposes of providing the comptroller with
- 26 information to operate and update the Political Subdivision Public
- 27 Information Warehouse under Section 403.0241, Government Code. The

- 2 information in a form and in the manner prescribed by the
- 3 <u>comptroller.</u>
- 4 Sec. 203.063. BOUNDARIES AND DISSOLUTION RECORDS. (a) A
- 5 political subdivision, other than a county or municipality, shall
- 6 transmit to the comptroller as provided by Section 203.062 each
- 7 information form, map, and plat, and any amendment to an
- 8 information form, map, or plat, and each statement regarding the
- 9 annexation or consolidation of the political subdivision.
- 10 <u>(a-1)</u> A political subdivision that is active on September 1,
- 11 2015, shall transmit the information required by Subsection (a) to
- 12 the comptroller not later than September 1, 2016. This subsection
- 13 expires January 1, 2017.
- 14 (b) A political subdivision created on or after September 1,
- 15 2015, shall transmit the information required by Subsection (a) to
- 16 the comptroller on or before the later of:
- 17 (1) September 1, 2016; or
- 18 (2) six months after the political subdivision's
- 19 creation date.
- 20 <u>(c) If after a political subdivision transmits the</u>
- 21 <u>information required by Subsection (a) to the comptroller the</u>
- 22 political subdivision's boundaries change or the political
- 23 subdivision dissolves, the political subdivision shall transmit to
- 24 the comptroller as provided by Section 203.062 and as applicable
- 25 each information form, map, and plat, and any amendment to an
- 26 information form, map, or plat, and each statement regarding the
- 27 dissolution, annexation, or consolidation of the district not later

- 1 than six months after the date the change in boundaries or
- 2 <u>dissolution occurs.</u>
- 3 <u>Sec. 203.064. FINANCIAL INFORMATION.</u> A political
- 4 subdivision shall transmit to the comptroller as provided by
- 5 Section 203.062 the following financial information:
- 6 (1) the political subdivision's most recently adopted
- 7 annual budget; and
- 8 (2) the political subdivision's most recent annual
- 9 financial report.
- 10 Sec. 203.065. INTERNET WEBSITE. A political subdivision
- 11 shall transmit to the comptroller as provided by Section 203.062
- 12 the address of the Internet website maintained by the political
- 13 subdivision, if any.
- 14 SECTION 4. The comptroller of public accounts shall create
- 15 and post on the Internet the Political Subdivision Public
- 16 Information Warehouse required by Section 403.0241, Government
- 17 Code, as added by this Act, not later than December 31, 2017.
- SECTION 5. This Act takes effect September 1, 2015.
