Sections 271.9051(a), (b), and (c), Local 9 Government Code, are amended to read as follows: 10 11 (a) This section applies only to a municipality or county 12 that is authorized under this title to purchase real property or personal property that is not affixed to real property. 13 14 (b) In purchasing under this title any real property, personal property that is not affixed to real property, 15 or services, if a municipality or county receives one or more 16 competitive sealed bids from a bidder whose principal place of 17 business is in the municipality or county and whose bid is within 18 five percent of the lowest bid price received by the municipality or 19 20 county from a bidder who is not a resident of the municipality or 21 county, the municipality or county may enter into a contract for construction services in an amount of less than \$100,000 or a 22 23 contract for other purchases in an amount of less than \$500,000 24 with:

(1) the lowest bidder; or

2 (2) the bidder whose principal place of business is in 3 the municipality <u>or county</u> if the governing body of the municipality or county determines, in writing, that the local 4 5 bidder offers the municipality or county the best combination of contract price and additional economic development opportunities 6 for the municipality or county created by the contract award, 7 8 including the employment of residents of the municipality or county and increased tax revenues to the municipality or county. 9

10 (c) This section does not prohibit a municipality <u>or county</u> 11 from rejecting all bids.

12 SECTION 3. The change in law made by this Act applies only 13 to a contract for which the initial notice soliciting bids is given 14 on or after the effective date of this Act. A contract for which the 15 initial notice soliciting bids is given before the effective date 16 of this Act is governed by the law in effect when the initial notice 17 is given, and the former law is continued in effect for that 18 purpose.

19 SECTION 4. This Act takes effect immediately if it receives 20 a vote of two-thirds of all the members elected to each house, as 21 provided by Section 39, Article III, Texas Constitution. If this 22 Act does not receive the vote necessary for immediate effect, this 23 Act takes effect September 1, 2015.
