- 3 insured by the Texas Windstorm Insurance Association.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 2210.251(f), Insurance Code, is amended
- 6 to read as follows:
- 7 (f) Notwithstanding any other provision of this section,
- 8 insurance coverage for a residential structure may be issued or
- 9 renewed through the association subject to the inspection
- 10 requirements imposed under Section 2210.258, if applicable. [This
- 11 subsection expires December 31, 2015.
- 12 SECTION 2. Sections 2210.258(a) and (c), Insurance Code,
- 13 are amended to read as follows:
- 14 (a) Except as provided by Subsection (c) [and Section
- 15 2210.2581] and notwithstanding any other provision of this chapter,
- 16 to be eligible for insurance through the association, all
- 17 construction, alteration, remodeling, enlargement, and repair of,
- 18 or addition to, any structure located in the catastrophe area that
- 19 is begun on or after the effective date of Sections 5 through 49,
- 20 H.B. [No.] 4409, [Acts of the] 81st Legislature, Regular Session,
- 21 2009, must be performed in compliance with the applicable building
- 22 code standards, as set forth in the plan of operation.
- 23 (c) The association may insure a residential structure
- 24 constructed, altered, remodeled, enlarged, repaired, or added to on

- 1 or after June 19, 2009, that is not in compliance with the
- 2 applicable building code standards, as set forth in the plan of
- 3 operation, provided that:
- 4 (1) the structure had been insured on or after June 19,
- 5 2009, by an insurer in the private market that canceled or
- 6 nonrenewed the insurance coverage of the structure [before December
- $7 \frac{31, 2015}{}$;
- 8 (2) the applicant provides to the association proof
- 9 that insurance coverage that was issued to the applicant or the
- 10 previous insured for the structure was canceled or nonrenewed in
- 11 the private market as described by Subdivision (1); and
- 12 (3) no construction, alteration, remodeling,
- 13 enlargement, or repair of, or addition to, the structure occurred
- 14 after cancellation or nonrenewal of the coverage and before
- 15 submission of an application for coverage through the association.
- SECTION 3. Section 2210.2581, Insurance Code, is repealed.
- 17 SECTION 4. This Act takes effect immediately if it receives
- 18 a vote of two-thirds of all the members elected to each house, as
- 19 provided by Section 39, Article III, Texas Constitution. If this
- 20 Act does not receive the vote necessary for immediate effect, this
- 21 Act takes effect September 1, 2015.
