Section 262.002, Occupations Code, is amended by 12 amending Subsection (a) and adding Subsection (c) to read as 13 14 follows: A person practices dental hygiene if the person: 15 (a) 16 (1) removes accumulated matter, tartar, deposits, 17 accretions, or stains, other than mottled enamel stains, from the natural and restored surface of exposed human teeth 18 and restorations in the human mouth: 19 20 smoothes roughened root surfaces; (2) 21 polishes exposed human teeth, restorations in the (3) human mouth, or roughened root surfaces; 22 23 (4) topically applies drugs to the surface tissues of 24 the human mouth or the exposed surface of human teeth; 25 (5) makes dental x-rays; [and] 26 (6) administers intraoral, block, or infiltration anesthesia under the authorization and supervision of a dentist; 27

2 (7) performs any other service, task, or procedure
3 prescribed by board rule.

4 (c) A dental hygienist may not establish an independent
5 practice to provide services authorized by this subtitle.

6 SECTION 3. (a) The State Board of Dental Examiners, not 7 later than January 1, 2016, shall:

8 (1) prescribe by rule the requirements for a course to 9 train dental hygienists to administer local anesthetic agents; and

10 (2) develop a procedure for the approval of courses11 described by Subdivision (1) of this subsection.

12 (b) A rule adopted under Subsection (a) of this section must13 require that a course is:

14 (1) accredited by the Commission on Dental15 Accreditation of the American Dental Association; and

16 (2) offered in a classroom setting at an educational 17 institution.

18 SECTION 4. This Act takes effect September 1, 2015.
