Article 7A.01(a), Code of Criminal Procedure, is 5 6 amended to read as follows: The following persons may file an application for a 7 (a) 8 protective order under this chapter without regard to the relationship between the applicant and the alleged offender: 9 a person who is the victim of an offense under 10 (1)Section 21.02, 21.11, 22.011, 22.021, or 42.072, Penal Code; 11 12 (2) a person who is the victim of an offense under 13 Section 20A.02, 20A.03, or 43.05, Penal Code; 14 (3) a parent or guardian acting on behalf of a person 15 younger than 17 years of age who is the victim of an offense listed in Subdivision (1); 16 a parent or guardian acting on behalf of a person 17 (4)younger than 18 years of age who is the victim of an offense listed 18 in Subdivision (2); or 19 (5) a prosecuting attorney acting on behalf of a 20 person described by Subdivision (1), [or] (2), (3), or (4). 21 22 SECTION 2. The heading to Article 56.021, Code of Criminal Procedure, is amended to read as follows: 23 Art. 56.021. RIGHTS OF VICTIM OF SEXUAL ASSAULT OR ABUSE, 24

STALKING, OR TRAFFICKING. 1 SECTION 3. Article 56.021, Code of Criminal Procedure, is 2 amended by adding Subsection (d) to read as follows: 3 4 (d) This subsection applies only to a victim of an offense under Section 20A.02, 20A.03, 21.02, 21.11, 22.011, 22.021, 42.072, 5 or 43.05, Penal Code. In addition to the rights enumerated in 6 7 Article 56.02 and, if applicable, Subsection (a) of this article, a victim described by this subsection or a parent or guardian of the 8 victim is entitled to the following rights within the criminal 9 justice system: 10 11 (1) the right to request that the attorney representing the state, subject to the Texas Disciplinary Rules of 12 13 Professional Conduct, file an application for a protective order under Article 7A.01 on behalf of the victim; 14 15 (2) the right to be informed: 16 (A) that the victim or the victim's parent or guardian, as applicable, may file an application for a protective 17 18 order under Article 7A.01; 19 (B) of the court in which the application for a 20 protective order may be filed; and (C) that, on request of the victim or of the 21 victim's parent or guardian, as applicable, and subject to the 22 Texas Disciplinary Rules of Professional Conduct, the attorney 23 representing the state may file the application for a protective 24 25 order; (3) if the victim or the victim's parent or guardian, 26 27 as applicable, is present when the defendant is convicted or placed

on deferred adjudication community supervision, the right to be 1 2 given by the court the information described by Subdivision (2) and, if the court has jurisdiction over applications for protective 3 orders that are filed under Article 7A.01, the right to file an 4 application for a protective order immediately following the 5 defendant's conviction or placement on deferred adjudication 6 7 community supervision; and (4) if the victim or the victim's parent or guardian, 8 9 as applicable, is not present when the defendant is convicted or placed on deferred adjudication community supervision, the right to 10 11 be given by the attorney representing the state the information described by Subdivision (2). 12

13 SECTION 4. The change in law made by this Act applies to a 14 victim of criminally injurious conduct for which a judgment of 15 conviction is entered or a grant of deferred adjudication is made on 16 or after the effective date of this Act, regardless of whether the 17 criminally injurious conduct occurred before, on, or after the 18 effective date of this Act.
