11	(2) "State agency" means a department, board,							
12	commission, or other agency in the executive branch of state							
13	government. The term does not include an institution of higher							
14	education as defined by Section 61.003, Education Code.							
15	Sec. 673.002. TRAINING MANUAL. (a) The governing body of							
16	a state agency or the single state officer who governs an agency							
17	shall adopt a training manual as provided by this section. The							
18	executive head of a state agency governed by a governing body shall							
19	ensure that each member of the body receives a copy of the manual							
20	each year.							
21	(b) The training manual must include, at a minimum:							
22	(1) the scope of and limitations on the rulemaking							
23	authority of the governing body or officer;
