A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to general officers within the state military department.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 4 SECTION 1. Section 437.058, Government Code, is amended by
- 5 amending Subsections (a), (d), (e), and (f) and adding Subsection
- 6 (d-1) to read as follows:
- 7 (a) The adjutant general may appoint as general officers one
- 8 <u>or more</u> [an] assistant deputy <u>adjutants</u> [adjutant] general for
- 9 army, an assistant deputy adjutant general for air, an assistant
- 10 [deputy] adjutant general for homeland security, and an assistant
- 11 [deputy] adjutant general for domestic operations [government
- 12 affairs].
- 13 (d) The assistant deputy <u>adjutants</u> [adjutant] general for
- 14 [the] army shall support the deputy adjutant general for [the]
- 15 army, represent the command staff at events as needed, and manage
- 16 the activities assigned by the adjutant general or the deputy
- 17 adjutant general for [the] army.
- 18 <u>(d-1)</u> The assistant deputy adjutant general for air shall
- 19 support the deputy adjutant general for air, represent the command
- 20 staff at events as needed, and manage the activities assigned by the
- 21 adjutant general or the deputy adjutant general for air.
- (e) The assistant [deputy] adjutant general for homeland
- 23 security [the Army National Guard or the Air National Guard], as
- 24 determined by the adjutant general, shall:

- 1 (1) coordinate with other state agencies in matters
- 2 pertaining to homeland security [to ensure state emergency services
- 3 are provided and organized to support the state operations center];
- 4 and
- 5 (2) coordinate homeland security actions taken by the
- 6 National Guard Bureau in this state.
- 7 (f) The assistant [deputy] adjutant general for domestic
- 8 operations [the Army National Guard or the Air National Guard, as
- 9 determined by the adjutant general, shall:
- 10 (1) coordinate activities of the Texas military forces
- 11 with the National Guard Bureau to ensure state emergency services
- 12 are provided and organized to support the state operations center;
- 13 and
- 14 (2) coordinate with other federal, state, and local
- 15 jurisdictions and officials [funding and coordination with other
- 16 federal, state, and local jurisdictions and officials in matters
- 17 relating to the operations of the Texas military forces occurring
- 18 in the assistant deputy adjutant general's jurisdiction or
- 19 oversight].
- 20 SECTION 2. This Act takes effect September 1, 2015.
