SECTION 1. Section 25.0001(a), Government Code, is amended 5 6 to read as follows:

provision of this subchapter conflicts with a specific provision 9

as provided by this section, the [The] drawing of jury panels, 14

15 selection of jurors, and practice in the statutory county courts

must conform to that prescribed by law for county courts. 16

17 Practice in a statutory county court is that prescribed 18 by law for county courts, except that practice, procedure, rules of evidence, issuance of process and writs, and all other matters 19 pertaining to the conduct of trials and hearings in the statutory 20 21

county courts[, other than the number of jurors,] that involve

- 20 six members unless the constitution or other law requires a
- 21 12-member jury.
- 22 SECTION 7. The change in law made by this Act applies only
- 23 to a trial commenced on or after the effective date of this ${\tt Act.}\ {\tt A}$
- 24 trial commenced before the effective date of this Act is governed by
- 25 the law in effect immediately before that date, and the former law
- 26 is continued in effect for that purpose.
- 27 SECTION 8. This Act takes effect September 1, 2015.
