A BILL TO BE ENTITLED

- 1 AN ACT
- 2 relating to the functions of the Office of Immigration and Refugee
- 3 Affairs and the Governor's Advisory Committee on Immigration and
- 4 Refugees.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 752.001, Government Code, is amended to
- 7 read as follows:
- 8 Sec. 752.001. OFFICE OF IMMIGRATION AND REFUGEE AFFAIRS.
- 9 The Office of Immigration and Refugee Affairs is [created] within
- 10 the <u>Health and Human Services Commission</u> [Texas Department of Human
- 11 Services]. The office shall work in conjunction with the office of
- 12 the secretary of state.
- 13 SECTION 2. Section 752.003, Government Code, is amended to
- 14 read as follows:
- 15 Sec. 752.003. REFUGEE COORDINATOR. (a) The secretary of
- 16 state serves as the refugee coordinator for the office unless the
- 17 governor appoints a person under Subsection (b).
- 18 (b) The governor may [shall] appoint a person other than the
- 19 secretary of state as refugee coordinator for the office to serve at
- 20 the pleasure of the governor.
- 21 (c) The refugee coordinator shall serve as chief
- 22 administrative officer of the office and shall ensure coordination
- 23 of public and private resources in refugee resettlement.
- SECTION 3. Section 752.004, Government Code, is amended to

- 1 read as follows:
- 2 Sec. 752.004. APPLICATION FOR AND DISTRIBUTION OF FEDERAL
- 3 FUNDS AND REIMBURSEMENTS. (a) The office shall apply for the
- 4 maximum amount of federal funds available through the Immigration
- 5 Reform and Control Act of 1986 (Pub. L. No. 99-603), the
- 6 Immigration and Nationality Act (8 U.S.C. Section 1101 et seq.),
- 7 [and] the Refugee Act of 1980 (8 U.S.C. Section 1521 et seq.), and
- 8 other federal programs, as appropriate, for use in assisting state
- 9 agencies, local governments, nonprofit organizations, and
- 10 faith-based organizations in addressing matters related to
- 11 <u>immigrants and refugees</u>. The office shall apply for those funds and
- 12 shall distribute the funds to agencies and other entities
- 13 responsible for providing services to <u>immigrants</u>, including newly
- 14 legalized aliens, and refugees in accordance with federal law. The
- 15 office may retain a portion of the federal funds to cover reasonable
- 16 costs incurred in securing and administering the funds. The office
- 17 may delegate to an appropriate state agency the administration of
- 18 funds under this section.
- 19 <u>(b) The office shall seek reimbursement from the federal</u>
- 20 government for any costs incurred by state agencies, local
- 21 governments, nonprofit organizations, and faith-based
- 22 organizations in addressing matters related to immigrants and
- 23 <u>refugees.</u>
- SECTION 4. Section 752.007, Government Code, is amended to
- 25 read as follows:
- Sec. 752.007. OTHER FUNCTIONS OF OFFICE. In addition to
- 27 other duties prescribed by this subchapter, the office shall:

- 1 (1) coordinate public and private programs for the
- 2 benefit of immigrants and refugees;
- 3 (2) receive and address inquiries relating to the
- 4 services available to immigrants or refugees at the local, state,
- 5 and federal levels; [and]
- 6 (3) assist local communities with the development of
- 7 programs to address the needs of immigrants and refugees at the
- 8 local level; and
- 9 <u>(4) arrange meetings with appropriate local, state,</u>
- 10 and federal authorities and the appropriate corresponding
- 11 authorities in Mexico to develop increased communication,
- 12 cooperation, and coordination to establish initiatives and
- 13 government-supported efforts that limit the entrance of
- 14 undocumented immigrants into this state.
- 15 SECTION 5. Section 752.021, Government Code, is amended to
- 16 read as follows:
- 17 Sec. 752.021. GOVERNOR'S ADVISORY COMMITTEE ON IMMIGRATION
- 18 AND REFUGEES. The Governor's Advisory Committee on Immigration and
- 19 Refugees is created within the office of the governor. The
- 20 committee shall advise and make recommendations to the Office of
- 21 Immigration and Refugee Affairs on immigration and refugee issues,
- 22 including [the SLIAG program authorized by the Immigration Reform
- 23 and Control Act of 1986 (8 U.S.C. Section 1101 et seq.) and the
- 24 refugee assistance programs [authorized by the Refugee Act of 1980
- 25 (8 U.S.C. Section 1521 et seq.)].
- SECTION 6. Sections 752.022(a) and (c), Government Code,
- 27 are amended to read as follows:

- 1 (a) The committee is composed of 12 members appointed by the
- 2 governor with the advice and consent of the senate as follows:
- 3 (1) two representatives of the refugee population;
- 4 (2) two representatives of the immigrant population;
- 5 (3) three representatives of local provider programs
- 6 that serve immigrants or refugees and that receive federal funds,
- 7 with one each from a public health program, a public assistance
- 8 program, and an education program;
- 9 (4) three representatives from faith-based
- 10 organizations that assist local governments with matters related to
- 11 immigrants and refugees [voluntary resettlement agencies that
- 12 receive state or federal funds];
- 13 (5) one representative from a legal organization that
- 14 is involved in issues relating to immigrants or refugees; and
- 15 (6) one representative from a service organization
- 16 that works with immigrants or refugees.
- 17 (c) The governor shall appoint a member of the committee to
- 18 serve as the chair of the committee [for a one-year term].
- 19 SECTION 7. Subchapter B, Chapter 752, Government Code, is
- 20 amended by adding Section 752.0231 to read as follows:
- 21 Sec. 752.0231. OTHER LAW. Section 2110.008 does not apply
- 22 to the committee.
- SECTION 8. Section 752.024, Government Code, is amended to
- 24 read as follows:
- Sec. 752.024. FUNCTIONS OF COMMITTEE. The committee shall:
- 26 (1) advise and make recommendations to the Office of
- 27 Immigration and Refugee Affairs regarding policy, planning, and

- 1 priorities for matters related to immigrants and refugees [the
- 2 <u>SLIAC program and refugee assistance programs</u>];
- 3 (2) advise and make recommendations to the Office of
- 4 Immigration and Refugee Affairs regarding coordination of the
- 5 efforts of all public agencies involved in health, human services,
- 6 and education matters that relate to federal immigration and
- 7 refugee laws and rules [or implementation of the SLIAC program or
- 8 refugee assistance programs];
- 9 (3) encourage communication and cooperation among
- 10 local agencies and programs, state agencies, immigration-related
- 11 and refugee-related legal and service agencies, and the federal
- 12 government;
- 13 (4) assist the Office of Immigration and Refugee
- 14 Affairs in applying for the maximum amount of federal funds
- 15 available for $\underline{immigrant-related}$ [SLIAG-related] programs and
- 16 activities and refugee-related programs and activities and in
- 17 identifying local programs and costs relating to immigration or
- 18 refugees for which the state or a political subdivision may receive
- 19 reimbursement;
- 20 (5) provide information to programs and activities
- 21 that serve and encourage legalization and education of residents of
- 22 this state;
- 23 (6) review <u>issues related to immigrants and refugees</u>
- 24 [federal issues regarding the SLIAG program and refugee assistance
- 25 programs] and make recommendations to the Office of Immigration and
- 26 Refugee Affairs to encourage the development of a state response to
- 27 those [federal] issues;

- [review and make recommendations to the Office of 1 (7)Immigration and Refugee Affairs and state agencies to ensure that 2 the system of fiscal and program operations for the SLIAG program 3 and refugee assistance programs is consistent with existing state 4 5 and federal requirements; 6 [(8)] assist the Office of Immigration and Refugee 7 Affairs in the development of an annual report on the status of
- 9 refugee assistance programs] in the state;

 10 (8) [(9)] advise and make recommendations to the

 11 Office of Immigration and Refugee Affairs on other related matters

 12 as directed by the governor; and

matters related to immigrants and refugees [the SLIAG program and

- (9) [(10)] assist the Office of Immigration and Refugee Affairs to better address issues related to immigrants and refugees confronting the state and local communities [in the development of a spending plan for fiscal years 1993 and 1994 proposing spending priorities for SLIAG funds for services to eligible legalized aliens and for other federal funds available to benefit immigrants or refugees in the state].
- SECTION 9. (a) Not later than January 1, 2016, the governor shall appoint the members of the Governor's Advisory Committee on Immigration and Refugees as provided by Section 752.022(a), Government Code, as amended by this Act. The committee is re-created on the date the governor makes the appointments as provided by this subsection.
- (b) Notwithstanding Section 752.022(b), Government Code, the terms of the members of the advisory committee appointed as

- 1 provided by Subsection (a) of this section expire February 1, 2017.
- 2 SECTION 10. This Act takes effect September 1, 2015.
