S.B. No. 844

A BILL TO BE ENTITLED

- 1 AN ACT
- 2 relating to the expiration of licenses for insurance agents and
- 3 adjusters.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Sections 4001.006(a) and (b), Insurance Code,
- 6 are amended to read as follows:
- 7 (a) The department shall collect from each agent of an
- 8 insurer writing insurance in this state under this code:
- 9 (1) a nonrefundable license application fee; and
- 10 (2) a nonrefundable appointment fee for each
- 11 appointment of the agent by an insurer.
- 12 (b) The department shall deposit the fees described by
- 13 Subsection (a), together with other license application fees,
- 14 examination fees, and license renewal application fees, to the
- 15 credit of the Texas Department of Insurance operating account.
- SECTION 2. Section 4003.001, Insurance Code, is amended by
- 17 amending Subsection (a) and adding Subsections (c) and (d) to read
- 18 as follows:
- 19 (a) Unless a staggered renewal system is adopted under
- 20 Section 4003.002, each [agent] license issued or renewed by the
- 21 department under Chapter 981 or Subtitles A, B, or C and not
- 22 suspended or revoked by the commissioner expires on:
- 23 (1) the second anniversary of the date the license is
- 24 issued to or renewed by a person that is not an individual; or

- 1 (2) except as provided in Subsection (c):
- 2 (A) for a license issued or renewed in an
- 3 even-numbered year, the individual license holder's birthday each
- 4 even-numbered year; or
- 5 <u>(B) for a license issued or renewed in an</u>
- 6 odd-numbered year, the individual license holder's birthday each
- 7 <u>odd-numbered year</u>.
- 8 <u>(c) If a person holds more than one license, all licenses</u>
- 9 issued to the person expire on the earliest expiration date of the
- 10 licenses held. Thereafter, all licenses expire in accordance with
- 11 Subsection (a).
- 12 (d) Notwithstanding Section 4003.002(b), the commissioner
- 13 may not prorate the initial application fee for a license based on
- 14 the expiration period of the license under Subsection (c).
- SECTION 3. Section 4003.008(b), Insurance Code, is amended
- 16 to read as follows:
- 17 (b) The person must pay to the department a fee equal to the
- 18 license application fee.
- 19 SECTION 4. Sections 4101.057(a), (b), and (d), Insurance
- 20 Code, are amended to read as follows:
- 21 (a) Before issuing or renewing a license under this chapter,
- 22 the department shall set and collect a nonrefundable license
- 23 application fee in an amount not to exceed \$50.
- (b) An applicant for a renewal license must remit the fee
- 25 required by Subsection (a) before the expiration of the [biennially
- 26 after the issuance of the original license being renewed. If the
- 27 applicant's license has been expired for not more than 90 days, an

- 1 applicant for a renewal license must remit, in addition to the fee
- 2 assessed under Subsection (a), a fee equal to one-half of the
- 3 original <u>application</u> [license] fee.
- 4 (d) Before issuing a duplicate license requested by an
- 5 adjuster, the department shall set and collect a duplicate license
- 6 application fee.
- 7 SECTION 5. Section 4101.061, Insurance Code, is amended to
- 8 read as follows:
- 9 Sec. 4101.061. EXPIRATION; RENEWAL. Expiration and
- 10 renewal of a license issued under this chapter are governed by
- 11 Chapter 4003, rules adopted by the commissioner, and [or] any
- 12 applicable provision of this code or another insurance law of this
- 13 state.
- 14 SECTION 6. Section 4102.062, Insurance Code, is amended to
- 15 read as follows:
- Sec. 4102.062. EXPIRATION. A license issued under this
- 17 chapter expires as provided by Chapter 4003 [on the second
- 18 anniversary of the date of issuance] unless suspended or revoked by
- 19 the commissioner.
- SECTION 7. Section 4102.064, Insurance Code, is amended to
- 21 read as follows:
- Sec. 4102.064. RENEWAL OF UNEXPIRED LICENSE. (a) A license
- 23 holder may renew a license that has not expired and has not been
- 24 suspended or revoked by filing with the department a properly
- 25 completed renewal application, in the form prescribed by the
- 26 commissioner, that demonstrates continued compliance with the
- 27 license requirements imposed under this chapter or adopted by rule

- 1 by the commissioner. The completed renewal application must be
- 2 accompanied by:
- 3 (1) a renewal application fee in the amount determined
- 4 by the commissioner under Section 4102.066(b); and
- 5 (2) evidence of compliance with the continuing
- 6 education requirements imposed under Section 4102.109.
- 7 (b) A license holder must submit the completed renewal
- 8 application, evidence of compliance with the continuing education
- 9 requirements, and the renewal application fee to the commissioner
- 10 not later than the 30th day before the second anniversary date of
- 11 the license.
- 12 (c) On the filing of a completed renewal application,
- 13 renewal application fee, and, if applicable, evidence of compliance
- 14 with the continuing education requirements, the original license
- 15 continues in force until:
- 16 (1) the department issues the renewal license; or
- 17 (2) the commissioner issues an order revoking the
- 18 license.
- 19 SECTION 8. Sections 4102.065(a), (b), and (d), Insurance
- 20 Code, are amended to read as follows:
- 21 (a) A person whose license has been expired for 90 days or
- 22 less may renew the license by:
- 23 (1) submitting to the department:
- 24 (A) a completed renewal application in the form
- 25 prescribed by the commissioner; and
- 26 (B) evidence of compliance with the continuing
- 27 education requirements; and

- 1 (2) paying to the department the required renewal
- 2 application fee and an additional fee that is equal to one-half of
- 3 the renewal application fee for the license.
- 4 (b) A person whose license has been expired for more than 90
- 5 days but less than one year may not renew the license but is
- 6 entitled to a new license without taking the applicable examination
- 7 if the person submits to the department:
- 8 (1) a new application;
- 9 (2) evidence of compliance with the continuing
- 10 education requirements;
- 11 (3) the license <u>application</u> fee; and
- 12 (4) an additional fee equal to one-half of the license
- 13 application fee.
- 14 (d) The department may renew without reexamination an
- 15 expired license of a person who was licensed in this state, moved to
- 16 another state, and is currently licensed and has been in continual
- 17 practice in the other state up to and including the date of the
- 18 application. The person must pay to the department a fee that is
- 19 equal to the license application fee.
- 20 SECTION 9. (a) The change in law made by this Act applies
- 21 only to a license issued or renewed on or after January 1, 2016. A
- 22 license issued or renewed before January 1, 2016, is governed by the
- 23 law as it existed immediately before the effective date of this Act,
- 24 and that law is continued in effect for that purpose.
- (b) On January 1, 2016, each license held on that date under
- 26 Chapter 981, Insurance Code, and Subtitles A, B, and C, Title 13,
- 27 Insurance Code, expires as follows:

- 1 (1) each license issued to a person that is not an
- 2 individual expires on the expiration date of the license with the
- 3 longest remaining term held by that person on January 1, 2016;
- 4 (2) each license issued to an individual expires, or
- 5 may be extended to expire, on the individual's birthday in the year
- 6 after the expiration date of the license with the longest remaining
- 7 term held by that person on January 1, 2016; and
- 8 (3) after a license expires as described by
- 9 Subdivision (1) or (2) of this subsection, the license renews and
- 10 expires as provided by Section 4003.001, Insurance Code, as amended
- 11 by this Act.
- 12 (c) To the extent that the term of an existing license is
- 13 extended under this section, the department may not charge an
- 14 additional fee or require a renewal application before the renewal
- 15 date established under this section.
- 16 (d) Except as provided by Subsection (e) of this section,
- 17 the change in law made by this Act does not change the continuing
- 18 education requirement for a license issued or renewed on or after
- 19 the effective date of this Act. The continuing education
- 20 requirement for a license issued or renewed before the effective
- 21 date of this Act is governed by the law as it existed immediately
- 22 before the effective date of this Act, and that law is continued in
- 23 effect for that purpose.
- (e) A licensee may not be required to complete additional
- 25 continuing education hours for a license during any period the
- 26 license was extended under this section beyond its original
- 27 expiration date.

1 SECTION 10. This Act takes effect January 1, 2016.
