S.B. No. 950 rendered under Chapter 85, Title 4, against the parent or other 1 2 person during the two-year period preceding the filing of the suit or during the pendency of the suit. 3 4 SECTION 2. Section 153.0071(e-1), Family Code, is amended to read as follows: 5 (e-1) Notwithstanding Subsections (d) and (e), a court may 6 7 decline to enter a judgment on a mediated settlement agreement if the court finds: 8 9 (1) that: 10 (A) [(1)] a party to the agreement was a victim 11 of family violence, and that circumstance impaired the party's 12 ability to make decisions; or 13 (B) the agreement would permit a person who is subject to registration under Chapter 62, Code of Criminal 14 Procedure, on the basis of an offense committed by the person when 15 16 the person was 17 years of age or older or who otherwise has a history or pattern of past or present physical or sexual abuse 17 directed against any person to: 18 19 (i) reside in the same household as the 20 child; or (ii) otherwise have unsupervised access to 21 the child; and 22 23 (2) that the agreement is not in the child's best 24 interest. 25 SECTION 3. The changes in law made by this Act apply only to a suit affecting the parent-child relationship pending in a trial 26 27 court on the effective date of this Act or filed on or after that

1 date. A suit affecting the parent-child relationship in which a 2 final order is rendered before the effective date of this Act is 3 governed by the law in effect on the date the order was rendered, 4 and the former law is continued in effect for that purpose.
