## A BILL TO BE ENTITLED

- 1 AN ACT
- 2 relating to the regulation of crafted precious metal dealers.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 4 SECTION 1. Section 1956.051(3), Occupations Code, is
- 5 amended to read as follows:
- 6 (3) "Crafted precious metal" means jewelry,
- 7 silverware, an art object, or another object, made wholly or partly
- 8 from precious metal, that is selling at less than 105 percent of the
- 9 scrap value of the object, other than a coin, a bar, or a
- 10 commemorative medallion[, or scrap or a broken item selling at five
- 11 percent or more than the scrap value of the item].
- 12 SECTION 2. Section 1956.0613, Occupations Code, is amended
- 13 to read as follows:
- 14 Sec. 1956.0613. INVESTIGATION BY COMMISSIONER; INSPECTION
- 15 OF RECORDS. (a) The commissioner shall:
- 16 (1) monitor the operations of a dealer to ensure
- 17 compliance with this subchapter [chapter]; and
- 18 (2) receive and investigate complaints against a
- 19 dealer or a person acting as a dealer.
- 20 (b) If the commissioner receives a written complaint
- 21 regarding a violation of this subchapter by a person, or has
- 22 reasonable cause to believe that a person is violating this
- 23 <u>subchapter</u>, the commissioner or the commissioner's authorized
- 24 representative may inspect any record, account, paper, book, or

- 1 correspondence of the person, regardless of whether the person is
- 2 registered as a dealer.
- 3 (c) The commissioner or the commissioner's authorized
- 4 representative may take statements under oath in an investigation
- 5 of a matter under this subchapter.
- 6 SECTION 3. Section 1956.063, Occupations Code, is amended
- 7 by amending Subsections (c) and (d) and adding Subsection (c-1) to
- 8 read as follows:
- 9 (c) For each transaction regulated by this subchapter, the
- 10 dealer shall submit a report on a preprinted and prenumbered form
- 11 prescribed by the commissioner or in the manner described by
- 12 Subsection (c-1). The form must include the following:
- 13 (1) the date of the transaction;
- 14 (2) a description of the crafted precious metal
- 15 purchased by the dealer;
- 16 (3) the name and physical address of the dealer; and
- 17 (4) the name, physical description, and physical
- 18 address of the seller or transferor.
- 19 (c-1) A dealer may submit a list required by Section
- 20 1956.062(b) in satisfaction of the reporting requirement of this
- 21 section if the list contains the information described by
- 22 Subsection (c).
- 23 (d) The dealer shall retain a copy of the report until the
- 24 later of:
- 25 (1) the second anniversary of the date the dealer
- 26 sells or otherwise disposes of the crafted precious metal purchased
- 27 by the dealer; or

- 1 (2) the third anniversary of the date the report is
- 2 filed.
- 3 SECTION 4. Sections 1956.064(b) and (c), Occupations Code,
- 4 are amended to read as follows:
- 5 (b) A peace officer who has reasonable suspicion to believe
- 6 that an item of crafted precious metal in the possession of a
- 7 dealer, or in the possession of another person on behalf of the
- 8 <u>dealer</u>, is stolen may place the item on hold for a period not to
- 9 exceed 60 days by issuing to the dealer or other person a written
- 10 notice that:
- 11 (1) specifically identifies the item alleged to be
- 12 stolen and subject to the hold; and
- 13 (2) informs the dealer or other person of the
- 14 requirements of Subsection (c).
- 15 (c) On receiving the notice, the dealer or other person may
- 16 not melt, deface, alter, or dispose of the identified crafted
- 17 precious metal until the hold is released in writing by a peace
- 18 officer of this state or a court order.
- 19 SECTION 5. Section 14.201, Finance Code, is amended to read
- 20 as follows:
- Sec. 14.201. INVESTIGATION AND ENFORCEMENT AUTHORITY.
- 22 Investigative and enforcement authority under this subchapter
- 23 applies only to:
- 24 <u>(1)</u> Section 339.001;
