3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
4	SECTION 1. Section 1956.051(3), Occupations Code, is
5	amended to read as follows:
6	(3) "Crafted precious metal" means jewelry,
7	silverware, an art object, or another object, made wholly or partly
8	from precious metal, that is selling at less than 105 percent of the
9	<u>scrap value of the object,</u> other than a coin, a bar, <u>or</u> a
10	commemorative medallion[, or scrap or a broken item selling at five
11	percent or more than the scrap value of the item].
12	SECTION 2. Section 1956.0613, Occupations Code, is amended
13	to read as follows:
14	Sec. 1956.0613. INVESTIGATION BY COMMISSIONER; INSPECTION
15	<u>OF RECORDS</u> . <u>(a)</u> The commissioner shall:
16	(1) monitor the operations of a dealer to ensure
17	compliance with this <u>subchapter</u> [ <del>chapter</del> ]; and
18	(2) receive and investigate complaints against a
19	dealer or a person acting as a dealer.
20	(b) If the commissioner receives a written complaint
21	regarding a violation of this subchapter by a person, or has
22	reasonable cause to believe that a person is violating this
23	subchapter, the commissioner or the commissioner's authorized
24	representative may inspect any record, account, paper, book, or

correspondence of the person, regardless of whether the person is 1 2 registered as a dealer. (c) The commissioner or the commissioner's authorized 3 representative may take statements under oath in an investigation 4 of a matter under this subchapter. 5 SECTION 3. Section 1956.063, Occupations Code, is amended 6 7 by amending Subsections (c) and (d) and adding Subsection (c-1) to read as follows: 8 9 (c) For each transaction regulated by this subchapter, the dealer shall submit a report on a preprinted and prenumbered form 10 prescribed by the commissioner or in the manner described by 11 <u>Subsection (c-1)</u>. The form must include the following: 12 (1) the date of the transaction; 13 a description of the crafted precious metal 14 (2) 15 purchased by the dealer; 16 (3) the name and physical address of the dealer; and 17 (4) the name, physical description, and physical 18 address of the seller or transferor. (c-1) A dealer may submit a list required by Section 19 1956.062(b) in satisfaction of the reporting requirement of this 20 section if the list contains the information described by 21 Subsection (c). 22 The dealer shall retain a copy of the report until the 23 (d) later of: 24 25 (1) the second anniversary of the date the dealer sells or otherwise disposes of the crafted precious metal purchased 26 27 by the dealer; or

3 SECTION 4. Sections 1956.064(b) and (c), Occupations Code, 4 are amended to read as follows:

5 (b) A peace officer who has reasonable suspicion to believe 6 that an item of crafted precious metal in the possession of a 7 dealer, or in the possession of another person on behalf of the 8 <u>dealer</u>, is stolen may place the item on hold for a period not to 9 exceed 60 days by issuing to the dealer <u>or other person</u> a written 10 notice that:

(1) specifically identifies the item alleged to be stolen and subject to the hold; and

13 (2) informs the dealer <u>or other person</u> of the 14 requirements of Subsection (c).

15 (c) On receiving the notice, the dealer <u>or other person</u> may 16 not melt, deface, alter, or dispose of the identified crafted 17 precious metal until the hold is released in writing by a peace 18 officer of this state or a court order.

SECTION 5. Section 14.201, Finance Code, is amended to read as follows:

21 Sec. 14.201. INVESTIGATION AND ENFORCEMENT AUTHORITY. 22 Investigative and enforcement authority under this subchapter 23 applies only to:
