6	SECTION 1. Subchapter J, Chapter 21, Education Code, is
7	amended by adding Section 21.4554 to read as follows:
8	Sec. 21.4554. READING-TO-LEARN ACADEMIES. (a) The
9	commissioner shall develop and make available reading-to-learn
10	academies for teachers who provide reading comprehension
11	instruction to students at the fourth or fifth grade level.
12	(b) A reading-to-learn academy developed under this
13	section:
14	(1) must include effective instructional practices
15	that promote student development of reading comprehension and
16	inferential and critical thinking;
17	(2) must provide training in the use of empirically
18	validated instructional methods that are appropriate for
19	struggling readers;
20	(3) may include material on writing instruction; and
21	(4) must provide participating teachers with access to
22	the academy training materials through the Internet after the
23	teachers attend the academy.
24	(c) The commissioner shall adopt criteria for selecting

teachers who may attend a reading-to-learn academy. In adopting 1 selection criteria under this subsection, the commissioner shall: 2 3 (1) require granting a priority to teachers employed 4 by a school district at a campus at which 50 percent or more of the students enrolled are educationally disadvantaged; and 5 6 (2) provide a process through which a teacher not 7 employed at a campus described by Subdivision (1) may attend the academy if the academy has available space and the school district 8 9 employing the teacher pays the costs of the teacher's attendance. 10 (d) From funds appropriated for that purpose, a teacher who 11 attends a reading-to-learn academy is entitled to receive a stipend in the amount determined by the commissioner. A stipend received 12 13 under this subsection is not considered in determining whether a district is paying the teacher the minimum monthly salary under 14 Section 21.402. 15 16 (e) On request of the commissioner, regional education service centers shall assist the commissioner and agency with 17 18 training and other activities relating to the development and operation of reading-to-learn academies. 19 20 (f) This section expires September 1, 2027. SECTION 2. This Act takes effect immediately if it receives 21 a vote of two-thirds of all the members elected to each house, as 22 provided by Section 39, Article III, Texas Constitution. If this 23 24 Act does not receive the vote necessary for immediate effect, this
