BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 1-23 SECTION 1. Section 191.0046, Health and Safety Code, is amended by adding Subsections (e) and (f) to read as follows: 1-24 (e) It is the intent of the legislature to not impose a cost for obtaining certified records for the purpose of obtaining an election identification certificate issued pursuant to Chapter 1-25 1-26 1-27 521A, Transportation Code. Notwithstanding any other law, the 1-28 state registrar, a local registrar, or a county clerk shall not charge a fee to an applicant that is associated with searching for or providing a record, including a certified copy of a birth record, if the applicant states that the applicant is requesting the record 1-29 1-30 1-31 1-32 for the purpose of obtaining an election identification certificate 1-33 under Section 521A.001, Transportation Code.
