## A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to the prohibited disposition of a decedent's remains by a
- 3 person charged with certain criminal conduct against the decedent;
- 4 providing an administrative penalty.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. This Act may be cited as the Holly Combs Act.
- 7 SECTION 2. Section 711.002(1), Health and Safety Code, is
- 8 amended to read as follows:
- 9 (1) A person listed in Subsection (a) may not control the
- 10 disposition of the decedent's remains if, in connection with the
- 11 decedent's death, an indictment has been filed charging the person
- 12 with a crime under Chapter 19, Penal Code, that involves family
- 13 violence against the decedent. A person regulated under Chapter
- 14 651, Occupations Code, who knowingly allows the person charged with
- 15 a crime to control the disposition of the decedent's remains in
- 16 violation of this subsection commits a prohibited practice under
- 17 Section 651.460, Occupations Code, and the Texas Funeral Service
- 18 Commission may take disciplinary action or assess an administrative
- 19 penalty against the regulated person under that chapter.
- SECTION 3. Section 651.460(a), Occupations Code, is amended
- 21 to read as follows:
- 22 (a) A person violates this chapter if the person:
- 23 (1) arranges for funeral services or merchandise and
- 24 fails to provide a customer with a purchase agreement as required by

- 1 Section 651.406;
- 2 (2) fails to retain and make available to the
- 3 commission, on request, copies of all price lists, written notices,
- 4 embalming documents, and memoranda of agreement required by this
- 5 chapter for two years after the date of distribution or signing;
- 6 (3) violates this chapter, a rule adopted under this
- 7 chapter, an order by the commission revoking, suspending, or
- 8 probating a license, an order assessing an administrative penalty,
- 9 or an agreement to pay an administrative penalty;
- 10 (4) allows the use of a dead human body by an embalming
- 11 establishment for research or educational purposes without
- 12 complying with Section 651.407; [or]
- 13 (5) is associated with a funeral establishment,
- 14 whether as an employee, agent, subcontractor, assignee, owner, or
- 15 otherwise, and fails to comply with this chapter or a rule adopted
- 16 under this chapter; or
- 17 (6) knowingly violates Section 711.002(1), Health and
- 18 Safety Code.
- 19 SECTION 4. This Act takes effect immediately if it receives
- 20 a vote of two-thirds of all the members elected to each house, as
- 21 provided by Section 39, Article III, Texas Constitution. If this
- 22 Act does not receive the vote necessary for immediate effect, this
- 23 Act takes effect September 1, 2015.
