1-20 relating to an unsworn declaration made by a private process server  
 1-21 in the performance of the server's job duties.

1-22 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-23 SECTION 1. Section 132.001, Civil Practice and Remedies  
 1-24 Code, is amended by amending Subsection (d) and adding Subsection  
 1-25 (g) to read as follows:

1-26 (d) Except as provided by Subsections (e), ~~and~~ (f), and  
 1-27 (g), an unsworn declaration made under this section must include a  
 1-28 jurat in substantially the following form:

2-2 governed by the law in effect immediately before the effective date  
2-3 of this Act, and that law is continued in effect for that purpose.  
2-4 SECTION 3. This Act takes effect September 1, 2015.
