A BILL TO BE ENTITLED

AN ACT

- 2 relating to a policy on vaccine-preventable diseases for public
 3 schools.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subchapter A, Chapter 38, Education Code, is
- 6 amended by adding Section 38.0022 to read as follows:
- 7 Sec. 38.0022. VACCINE-PREVENTABLE DISEASE POLICY REQUIRED.
- 8 (a) In this section:
- 9 <u>(1) "School employee" means an employee of a public</u>
- 10 school.

- 11 "Vaccine-preventable diseases" means the diseases
- 12 <u>included in the most current recommendations of the Advisory</u>
- 13 Committee on Immunization Practices of the Centers for Disease
- 14 Control and Prevention.
- 15 (b) Each public school shall develop and implement a policy
- 16 to protect the students attending the public school from
- 17 vaccine-preventable diseases.
- 18 (c) The policy must:
- 19 (1) require each school employee to receive vaccines
- 20 for the vaccine-preventable diseases specified by the school based
- 21 on the level of risk the employee presents to students by the
- 22 employee's routine and direct exposure to students;
- 23 (2) specify the vaccines a school employee is required
- 24 to receive based on the level of risk the employee presents to

- 1 students by the employee's routine and direct exposure to students;
- 2 (3) include procedures for verifying whether a school
- 3 employee has complied with the policy;
- 4 (4) include procedures for a school employee to be
- 5 exempt from the required vaccines for the medical conditions
- 6 identified as contraindications or precautions by the Centers for
- 7 <u>Disease Control and Prevention;</u>
- 8 <u>(5) for a school employee who is exempt from the</u>
- 9 required vaccines, include procedures the employee must follow to
- 10 protect students attending the school from exposure to disease,
- 11 such as the use of protective medical equipment, including gloves
- 12 and masks, based on the level of risk the employee presents to
- 13 students by the employee's routine and direct exposure to students;
- 14 (6) prohibit discrimination or retaliatory action
- 15 <u>against a school employee who is exempt from the required vaccines</u>
- 16 for the medical conditions identified as contraindications or
- 17 precautions by the Centers for Disease Control and Prevention,
- 18 except that required use of protective medical equipment, including
- 19 gloves and masks, may not be considered retaliatory action for
- 20 purposes of this subdivision;
- 21 (7) require the public school to maintain a written or
- 22 electronic record of each school employee's compliance with or
- 23 exemption from the policy; and
- 24 (8) state the disciplinary actions the public school
- 25 is authorized to take against a school employee who fails to comply
- 26 with the policy.
- 27 (d) The commissioner shall adopt rules as necessary to

- 1 <u>implement this section.</u>
- 2 SECTION 2. Not later than June 1, 2016, the commissioner of
- 3 education shall adopt the rules necessary to implement Section
- 4 38.0022, Education Code, as added by this Act.
- 5 SECTION 3. Notwithstanding Section 38.0022, Education
- 6 Code, as added by this Act, a school district or open-enrollment
- 7 charter school subject to that section is not required to have a
- 8 policy on vaccine-preventable diseases in effect until September 1,
- 9 2016.
- 10 SECTION 4. This Act takes effect September 1, 2015.
