4	SECTION 1. Title 4, Property Code, is amended by adding
5	Chapter 30 to read as follows:
6	CHAPTER 30. WRIT OF ASSISTANCE FOR REPOSSESSION OF AIRCRAFT
7	Sec. 30.01. DEFINITIONS. In this chapter:
8	(1) "Aircraft" means a self-propelled motor vehicle
9	that can be used to transport a person by flight in the air.
10	(2) "Repossession" means the recovery of an aircraft
11	that has been sold under a security agreement containing a
12	repossession clause authorizing the lender to recover the aircraft
13	if the borrower defaults under the agreement.
1 /	(3) "Panassassian agent" maans an individual who is

- 14 (3) "Repossession agent" means an individual who is authorized to engage in a repossession for a lender.
- 16 Sec. 30.02. WRIT OF ASSISTANCE FOR REPOSSESSION OF
- 17 AIRCRAFT. (a) A writ of assistance for the repossession of an
- 18 <u>aircraft authorizes a peace officer to assist and protect a</u>
- 19 repossession agent in gaining possession of the aircraft while the
- 20 <u>agent:</u>
- 21 (1) secures the aircraft on site; or
- 22 (2) prepares the aircraft, which may include a
- 23 mechanical inspection, for removal from the site by flight or
- 24 otherwise to another location.

- 1 (b) A writ of assistance for the repossession of an aircraft
- 2 is valid for 30 days.
- 3 (c) A justice court may grant unlimited extensions of a writ
- 4 of assistance issued under this chapter.
- 5 Sec. 30.03. PETITION FOR WRIT OF ASSISTANCE. (a) A
- 6 repossession agent may file a petition in a justice court for a writ
- 7 of assistance for the repossession of an aircraft.
- 8 (b) The repossession agent is entitled to the writ if the
- 9 repossession agent establishes that:
- 10 (1) the aircraft is subject to the proposed
- 11 repossession; and
- 12 (2) the repossession agent is authorized to engage in
- 13 the repossession.
- 14 (c) The petition for the writ must include a copy of:
- 15 (1) the security agreement relating to the aircraft;
- 16 (2) the notice of default under the security agreement
- 17 sent by the lender to the borrower;
- 18 (3) the instrument in which a power of attorney for the
- 19 repossession is granted to the repossession agent by the lender;
- 20 and
- 21 (4) the results of a title search of the Federal
- 22 Aviation Administration's records for the aircraft.
- 23 SECTION 2. This Act takes effect September 1, 2015.
