1 AN ACT

- 2 relating to a waiver of fees by the Department of Agriculture and
- 3 the Parks and Wildlife Department for certain educational programs
- 4 involving aquaculture and hydroponics.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 134.014, Agriculture Code, is amended to
- 7 read as follows:
- 8 Sec. 134.014. LICENSE FEES; WAIVERS. (a) The department
- 9 shall issue an aquaculture license or a fish farm vehicle license on
- 10 completion of applicable license requirements and the payment of a
- 11 fee by the applicant, as provided by department rule.
- 12 (b) The department by rule shall waive the initial and
- 13 renewal aquaculture license fees if the license or license renewal
- 14 <u>is requested by a public school to establish and maintain an</u>
- 15 educational program that will give students experience with a
- 16 sustainable system of agriculture that mixes aquaculture and
- 17 hydroponics. To qualify for the fee waiver, the school must submit
- 18 an application to the department showing that the school's program
- 19 meets the department's requirements, including requirements for
- 20 <u>supervision</u>, handling of the fish species, and control of wastes.
- 21 SECTION 2. Section 66.007, Parks and Wildlife Code, is
- 22 amended by adding Subsection (c-1) to read as follows:
- 23 (c-1) The commission by rule shall waive the initial and
- 24 renewal fees for an exotic species permit if the permit or permit

- 1 renewal is requested by a public school to establish and maintain an
- 2 educational program that will give students experience with a
- 3 sustainable system of agriculture that mixes aquaculture and
- 4 hydroponics. To qualify for the fee waiver, the school must submit
- 5 an application to the department showing that the school's program
- 6 meets the department's requirements, including requirements for
- 7 supervision, handling of the exotic species, and control of wastes.
- 8 SECTION 3. (a) The Department of Agriculture shall adopt
- 9 rules required to implement Section 134.014, Agriculture Code, as
- 10 amended by this Act, not later than December 31, 2015.
- 11 (b) The Parks and Wildlife Commission shall adopt rules
- 12 required to implement Section 66.007(c-1), Parks and Wildlife Code,
- 13 as added by this Act, not later than December 31, 2015.
- 14 SECTION 4. This Act takes effect immediately if it receives
- 15 a vote of two-thirds of all the members elected to each house, as
- 16 provided by Section 39, Article III, Texas Constitution. If this
- 17 Act does not receive the vote necessary for immediate effect, this
- 18 Act takes effect September 1, 2015.
