## A BILL TO BE ENTITLED

- 1 AN ACT
- 2 relating to the use of human remains for forensic science
- 3 education, including the training of search and rescue animals.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 691.022(a), Health and Safety Code, is
- 6 amended to read as follows:
- 7 (a) The board shall distribute bodies and anatomical
- 8 specimens to institutions and other persons authorized to receive
- 9 them.
- 10 SECTION 2. Section 691.0225, Health and Safety Code, is
- 11 amended to read as follows:
- 12 Sec. 691.0225. INFORMATIONAL DOCUMENT. The board shall
- 13 develop a document to inform a person making a gift of a decedent's
- 14 body or anatomical specimen for purposes of education, including
- 15 forensic science education, or research of the risks and benefits
- 16 associated with donation. The board shall make the document
- 17 available on the board's Internet website.
- SECTION 3. Section 691.023(a), Health and Safety Code, is
- 19 amended to read as follows:
- 20 (a) An officer, employee, or representative of the state, of
- 21 a political subdivision, or of an institution having charge or
- 22 control of a body not claimed for burial or a body required to be
- 23 buried at public expense shall:
- 24 (1) notify the board or the board's representative of

- 1 the body's existence when the body comes into the person's
- 2 possession, charge, or control if notified in writing to do so by
- 3 the board or the board's representative;
- 4 (2) deliver the body in accordance with the direction
- 5 of the board; and
- 6 (3) allow the board, the board's representative, or a
- 7 physician designated by the board who complies with this chapter to
- 8 remove the body to be used for the advancement of medical  $\underline{\text{or}}$
- 9 <u>forensic</u> science.
- 10 SECTION 4. Section 691.026, Health and Safety Code, is
- 11 amended to read as follows:
- Sec. 691.026. BODY OF TRAVELER. If an unclaimed body is the
- 13 body of a traveler who died suddenly, the board shall direct the
- 14 institution or other person receiving the body to retain the body
- 15 for six months for purposes of identification.
- SECTION 5. Section 691.028(a), Health and Safety Code, is
- 17 amended to read as follows:
- 18 (a) An adult living in this state who is of sound mind may
- 19 donate the adult's [his] body by will or other written instrument to
- 20 the board, a medical or dental school, or another donee authorized
- 21 by the board, to be used for the advancement of medical or forensic
- 22 science.
- SECTION 6. Section 691.030(a), Health and Safety Code, is
- 24 amended to read as follows:
- 25 (a) The board or the board's representative shall
- 26 distribute bodies donated to it and may redistribute bodies donated
- 27 to medical or dental schools or other donees authorized by the board

- 1 to<u>:</u>
- 2 <u>(1)</u> schools and colleges of chiropractic, osteopathy,
- 3 medicine, or dentistry incorporated in this state;
- 4 (2) forensic science programs;
- 5 (3) search and rescue organizations or recovery teams
- 6 that are recognized by the board, are exempt from federal taxation
- 7 under Section 501(c)(3), Internal Revenue Code of 1986, and use
- 8 <u>human remains detection canines with the authorization of a local</u>
- 9 or county law enforcement agency;
- 10 (4)  $[ \frac{1}{7} \text{ to} ]$  physicians;  $[ \frac{1}{7} ]$  and
- 11 (5) [to] other persons as provided by this section.
- 12 SECTION 7. Sections 691.033(a), (c), and (d), Health and
- 13 Safety Code, are amended to read as follows:
- 14 (a) To further medical or forensic science, a school,
- 15 college, or person designated by the board may use, dissect,
- 16 operate on, examine, and experiment on a body or anatomical
- 17 specimen distributed under this chapter.
- 18 (c) A law relating to the prevention of mutilation of a body
- 19 does not apply to the use of a body as authorized under this section
- 20 or a dissection, operation, examination, or experiment performed
- 21 under this section.
- 22 (d) To aid prosecutions under Section 42.08, Penal Code, the
- 23 board shall adopt rules that clearly state the activities that are
- 24 authorized by the board in relation to the  $\underline{\text{use or}}$  dissection of a
- 25 body.
- 26 SECTION 8. Sections 691.034(a), (c), and (d), Health and
- 27 Safety Code, are amended to read as follows:

- 1 (a) The board shall inspect and may approve institutions and
- 2 other persons for the receipt and use of bodies and anatomical
- 3 specimens under this chapter.
- 4 (c) The board may suspend or revoke a person's or
- 5 institution's authorization to receive and use or dissect bodies or
- 6 anatomical specimens if the board determines that the person or
- 7 institution has improperly used a body or anatomical specimen.
- 8 (d) A person or institution is entitled to a hearing before
- 9 the board or a hearing examiner appointed by the board before the
- 10 board may revoke the person's or institution's authorization to
- 11 receive and use or dissect bodies or anatomical specimens. The
- 12 board shall make all final decisions to suspend or revoke an
- 13 authorization.
- 14 SECTION 9. Section 692A.002, Health and Safety Code, is
- 15 amended by adding Subdivision (11-a) to read as follows:
- 16 (11-a) "Education" with respect to the purposes
- 17 <u>authorized by law for making an anatomical gift includes forensic</u>
- 18 science education and related training.
- 19 SECTION 10. Sections 692A.011(a) and (b), Health and Safety
- 20 Code, are amended to read as follows:
- 21 (a) An anatomical gift may be made to the following persons
- 22 named in the document of gift:
- 23 (1) an organ procurement organization to be used for
- 24 transplantation, therapy, research, or education;
- 25 (2) a hospital to be used for research;
- 26 (3) subject to Subsection (d), an individual
- 27 designated by the person making the anatomical gift if the

- 1 individual is the recipient of the part;
- 2 (4) an eye bank or tissue bank, except that use of a
- 3 gift of a whole body must be coordinated through the Anatomical
- 4 Board of the State of Texas;
- 5 (5) a forensic science program at:
- 6 (A) a general academic teaching institution as
- 7 defined by Section 61.003, Education Code; or
- 8 (B) a private or independent institution of
- 9 higher education as defined by Section 61.003, Education Code; [or]
- 10 (6) a search and rescue organization or recovery team
- 11 that is recognized by the Anatomical Board of the State of Texas, is
- 12 exempt from federal taxation under Section 501(c)(3), Internal
- 13 Revenue Code of 1986, and uses human remains detection canines with
- 14 the authorization of a local or county law enforcement agency; or
- 15 (7) the Anatomical Board of the State of Texas.
- 16 (b) Except for donations described by Subsections (a)(1)
- 17 through (6)  $[\frac{(5)}{(5)}]$ , the Anatomical Board of the State of Texas shall
- 18 be the donee of gifts of bodies or parts of bodies made for the
- 19 purpose of education or research that are subject to distribution
- 20 by the board under Chapter 691.
- 21 SECTION 11. As soon as practicable after the effective date
- 22 of this Act, the Anatomical Board of the State of Texas shall adopt
- 23 the rules necessary to implement the changes in law made by this Act
- 24 to Chapter 691, Health and Safety Code, and Section 692A.011,
- 25 Health and Safety Code.
- 26 SECTION 12. This Act takes effect September 1, 2015.
