4 winding up and termination to the extent authorized by this 5 chapter; and

6 <u>(4) make distributions of its income to the</u> 7 <u>corporation's members who are nonprofit corporations organized</u> 8 <u>under this code and who are exempt from income taxation under</u> 9 <u>Section 501(a), Internal Revenue Code of 1986, by being listed</u> 10 <u>under Section 501(c)(3) of that code, if:</u>

11 <u>(A) the distributions are made in accordance with</u> 12 <u>the purpose or purposes of the corporation as stated in the</u> 13 <u>certificate of formation and with the fiduciary responsibilities of</u> 14 <u>the board of directors, including the duty to safeguard restricted</u> 15 <u>funds for their intended purposes; and</u>

(B) after the distributions are complete:
(i) the corporation would be able to pay the

SECTION 4. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2015.
