- 5 SECTION 1. Section 651.051(a), Occupations Code, is amended

- 7 (a) The Texas Funeral Service Commission consists of seven
- 8 members appointed by the governor, with the advice and consent of
- 9 the senate as follows:
- 10 (1) two members who are licensed as both an embalmer
- 11 and a funeral director for at least the five years preceding
- 12 appointment to the commission;
- 13 (2) one member who is <u>licensed as a funeral director</u>
- 14 and is a registered cemetery owner or operator; and
- 15 (3) four members who represent the public and who:
- 16 (A) are not regulated under this chapter; and
- 17 (B) have consistently shown an interest in
- 18 supporting consumer protection.
- SECTION 2. Section 651.055(c), Occupations Code, is amended
- 20 to read as follows:
- 21 (c) It is a ground for removal from the commission that a
- 22 member:
- 23 (1) does not have at the time of appointment the
- 24 qualifications required by Sections 651.051(a) and (c) and

- 5 (3) violates a prohibition established by Sections

- 7 (4) cannot because of illness or disability discharge
- 8 the member's duties for a substantial part of the term for which the
- 9 member is appointed; or
- 10 (5) is absent for more than half of the regularly
- 11 scheduled commission meetings that the member is eligible to attend
- 12 during a calendar year unless the absence is excused by majority
- 13 vote of the commission.

- 13 penalty in amounts reasonable and necessary to administer the
- 14 provisional license program.
- 15 (c) The commission shall set the following fees in amounts
- 16 <u>reasonable and necessary to administer the continuing education</u>
- 17 program under this chapter:
- 18 (1) the continuing education provider fee and
- 19 continuing education course fee; and
- 20 (2) the continuing education noncompliance fee [may
- 21 not charge a fee to a perpetual care cemetery, including a fee for
- 22 issuing or renewing a license issued under this chapter].
- 23 SECTION 7. Sections 651.157, 651.1571, and 651.158,
- 24 Occupations Code, are amended to read as follows:
- Sec. 651.157. INSPECTION OF [CEMETERY,] CREMATORY[ $_{\tau}$ ] OR
- 26 FUNERAL ESTABLISHMENT. (a) A crematory or funeral establishment
- 27 must be inspected before an initial license may be issued to the

- (a-1) Except as provided by Subsection (b), a [licensed cemetery,] crematory[,] or funeral establishment shall be inspected at least once every two years by an agent of the commission or by an agent of the state or a political subdivision authorized by the commission to make inspections on its behalf.
- 7 (b) If the commission finds a violation of this chapter or 8 of Chapter 193, 361, 711, [714, 715,] or 716, Health and Safety 9 Code, the commission shall inspect the [cemetery,] crematory[,] or 10 funeral establishment annually until the commission determines 11 that the crematory or funeral establishment is free of violations.
- 12 (c) A report of each inspection made under this section
  13 shall be retained in the crematory's or funeral establishment's
  14 licensing file [filed with the commission].
- 15 (d) The commission by rule shall establish:
- 16 (1) procedures for the inspection of a [ $\frac{cemetery_{\tau}}{r}$ ]
  17 crematory[ $\frac{1}{\tau}$ ] or funeral establishment required by this section; and
- 18 (2) criteria, including consideration of the
- 19 crematory's or funeral establishment's inspection and complaint
- 20 history, regarding when the commission should inspect a crematory
- 21 or funeral [an] establishment based on the risk of a violation at  $\underline{a}$
- 22 crematory or funeral [an] establishment.
- (e) A premises on which funeral directing, [interment,]
- 24 cremation, or embalming is practiced shall be open at all times to
- 25 inspection for any violation of this chapter or of Chapter 193, 361,
- 26 or 716, Health and Safety Code, by:
- 27 (1) an agent of the commission;

- 1 (2) an authorized agent of the state; or
- 2 (3) an authorized agent of the county or municipality
- 3 in which the premises is located.
- 4 (f) Before a commission agent inspects a [cemetery,]
- 5 crematory  $[\tau]$  or funeral establishment, the agent shall review the
- 6 inspection reports filed with the commission on the <u>crematory or</u>
- 7 funeral establishment. During the inspection, the agent shall
- 8 determine whether previously identified problems have been
- 9 corrected and whether a pattern of violations exists. The
- 10 commission shall consider the information from the inspection
- 11 reports in determining whether a penalty should be imposed against
- 12 a crematory or funeral [an] establishment.
- 13 Sec. 651.1571. INSPECTION REQUIREMENTS FOR CERTAIN
- 14 CEMETERIES [+ EXCEPTION FOR PERPETUAL CARE CEMETERIES]. (a)  $\underline{A}$
- 15 cemetery licensed by the commission [This section and Section
- 16 651.157 do not apply to perpetual care cemeteries.
- 17 [(b) Except as provided by Section 651.157(b):
- 18 [(1) a cemetery] may not be inspected unless:
- (1)  $[\frac{(A)}{A}]$  an interment has occurred in the cemetery

- 4 inspection of those facilities by an entity other than the [Texas]

- 6 (b) The commission by rule shall establish procedures for an
- 7 inspection required under this section.
- 8 SECTION 8. Section 651.004, Occupations Code, is
- 9 transferred to Subchapter D, Chapter 651, Occupations Code, and
- 10 redesignated as Section 651.168, Occupations Code, to read as
- 11 follows:
- 12 Sec. 651.168 [651.004]. REGULATION OF CEMETERY AND
- 13 CREMATORY SERVICES. (a) The commission shall regulate cemetery
- 14 and crematory services as provided by this chapter and Chapter 716,
- 15 Health and Safety Code.
- 16 (b) The commission may not regulate cemetery or crematory
- 17 services that occur after burial or inurnment unless the services

(a) 2 The examinations for a funeral director's license and an embalmer's license shall be held at least annually. The examinations shall be 4 given at the time and place designated by the commission. The 5 commission shall give notice of the examinations. 6 [(b) Not later than the 30th day after the date a person 7 8 takes a licensing examination under this chapter, the commission shall notify the person of the results of the examination. 10 [(c) If the examination is graded or reviewed by a testing service: 11 [(1) the commission shall notify the person of the 12 results of the examination not later than the 14th day after the 13 14 date the commission receives the results from the testing service; 15 and [(2) if notice of the examination results will be 16 delayed for longer than 90 days after the examination date, the 17 commission shall notify the person of the reason for the delay 18 before the 90th day. 19 20 [(d) The commission may require a testing service to notify a person of the results of the person's examination. 21 [(e) If requested in writing by a person who fails a 22 licensing examination administered under this chapter, the 23 24 commission shall furnish the person with an analysis of the person's performance on the examination. 25
