- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subchapter A, Chapter 521, Transportation Code,
- 6 is amended by adding Section 521.010 to read as follows:
- 7 Sec. 521.010. SERVICES INFORMATION FOR VETERANS. The
- 8 department and the Texas Veterans Commission shall jointly develop
- 9 for veterans who receive a driver's license or personal
- 10 identification certificate with a veteran's designation a one-page
- 11 informational paper about veterans services provided by this state.
- 12 SECTION 2. Section 521.102, Transportation Code, is amended
- 13 by adding Subsection (c) to read as follows:
- 14 (c) The department shall provide to the recipient of a
- 15 personal identification certificate with a veteran's designation
- 16 the informational paper described by Section 521.010 at the time
- 17 the certificate is issued.
- 18 SECTION 3. Section 521.1235, Transportation Code, is
- 19 amended by adding Subsection (c) to read as follows:
- 20 <u>(c) The department shall provide to the recipient of a</u>
- 21 driver's license with a veteran's designation the informational
- 22 paper described by Section 521.010 at the time the license is
- 23 issued.
- SECTION 4. Subchapter R, Chapter 521, Transportation Code,

- 1 is amended by adding Section 521.4261 to read as follows:
- 2 Sec. 521.4261. REDUCED FEES FOR VETERANS. (a) Except as
- 3 provided by Subsection (c) and Section 521.426, the fee for the
- 4 issuance of a personal identification certificate or driver's
- 5 license for a person who qualifies for a veteran's designation
- 6 under Section 521.102 or 521.1235 is half the amount of the fee that
- 7 would otherwise apply under this chapter.
- 8 (b) The department shall adopt rules relating to the proof
- 9 of entitlement to a fee reduction under this section.
- (c) Subsection (a) does not apply to a person subject to the
- 11 registration requirements of Chapter 62, Code of Criminal
- 12 Procedure.
- SECTION 5. Section 521.4261, Transportation Code, as added
- 14 by this Act, applies only to a driver's license or personal
- 15 identification certificate for which an application was submitted
- 16 on or after the effective date of this Act. A driver's license or
- 17 personal identification certificate for which an application was
- 18 submitted before the effective date of this Act is governed by the
- 19 law in effect when the application was submitted, and the former law
- 20 is continued in effect for that purpose.
- 21 SECTION 6. This Act takes effect September 1, 2015.
