- 2 relating to the Alamo preservation fund and the establishment of an
- 3 Alamo preservation fund advisory committee.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subchapter I, Chapter 31, Natural Resources
- 6 Code, is amended by adding Sections 31.4545 and 31.4546 to read as
- 7 follows:
- 8 Sec. 31.4545. ALAMO PRESERVATION FUND. (a) The Alamo
- 9 preservation fund is a special fund in the state treasury outside
- 10 the general revenue fund as established by Section 49-q, Article
- 11 III, Texas Constitution.
- 12 (b) The land office shall manage the Alamo preservation fund
- 13 and may accept a gift, grant, or donation of money, securities,
- 14 services, or property to restore, preserve, maintain, operate, and
- 15 develop the Alamo complex.
- 16 <u>(c) The land office may spend money from the Alamo</u>
- 17 preservation fund only for the restoration, preservation,
- 18 maintenance, operation, or development of the Alamo complex and
- 19 only in amounts that are less than or equal to the amounts received
- 20 by the land office from federal, local, or private sources, which
- 21 the land office may spend for the same purposes.
- 22 (d) The land office shall retain not less than \$25 million
- 23 in an account in the Alamo preservation fund to be known as the
- 24 Alamo operation and maintenance trust account. The land office may

- 1 spend the interest and other earnings from the trust account for the
- 2 operation, maintenance, and improvement of the Alamo complex.
- 3 Sec. 31.4546. ALAMO PRESERVATION FUND ADVISORY COMMITTEE.
- 4 (a) The Alamo preservation fund advisory committee is established
- 5 to advise the land office on expenditures of money from the Alamo
- 6 preservation fund. The advisory committee consists of 15 members
- 7 appointed as follows:
- 8 (1) three members appointed by the governor;
- 9 <u>(2) three members appointed by the lieutenant</u>
- 10 governor;
- 11 (3) three members appointed by the speaker of the
- 12 house of representatives;
- 13 (4) three members appointed by the commissioner of the
- 14 land office;
- 15 (5) two members appointed by the San Antonio City
- 16 Council; and
- 17 (6) one member appointed by the Bexar County
- 18 Commissioners Court.
- 19 (b) Members of the advisory committee serve staggered
- 20 three-year terms with the terms of five members expiring January 1
- 21 of each year.
- 22 <u>(c) The commissioner of the land office shall appoint a</u>
- 23 member to serve as presiding officer of the advisory committee.
- 24 (d) The advisory committee shall make recommendations to
- 25 the land office on the best use of money in the Alamo preservation
- 26 fund to create a world-class site to educate visitors on the history
- 27 and importance of the Alamo in this state's fight for independence,

- 1 to honor the people who lost their lives at the Alamo, and to
- 2 develop the complex and surrounding grounds, including providing
- 3 education and museum facilities, financing studies and planning,
- 4 providing architectural services, acquiring land or buildings, and
- 5 constructing facilities.
- 6 (e) Chapter 2110, Government Code, does not apply to the
- 7 <u>advisory committee.</u>
- 8 SECTION 2. Not later than January 1, 2016, as required by
- 9 Section 31.4546, Natural Resources Code, as added by this Act:
- 10 (1) the governor, lieutenant governor, speaker of the
- 11 house of representatives, and the commissioner of the General Land
- 12 Office shall each appoint three members to the Alamo preservation
- 13 fund advisory committee and each designate one of their appointed
- 14 members to a term expiring January 1, 2017, one to a term expiring
- 15 January 1, 2018, and one to a term expiring January 1, 2019;
- 16 (2) the San Antonio City Council shall appoint two
- 17 members to the Alamo preservation fund advisory committee and
- 18 designate one member to a term expiring January 1, 2017, and one to
- 19 a term expiring January 1, 2018; and
- 20 (3) the Bexar County Commissioners Court shall appoint
- 21 one member to the Alamo preservation fund advisory committee to a
- 22 term expiring January 1, 2019.
- 23 SECTION 3. This Act takes effect December 1, 2015, but only
- 24 if the constitutional amendment to establish the Alamo preservation
- 25 fund and make a one-time transfer of money from the economic
- 26 stabilization fund to the Alamo preservation fund is approved by
- 27 the voters. If that amendment is not approved by the voters, this
