S.B. No. 1365

A BILL TO BE ENTITLED

1 AN ACT
2 relating to the territory of the Harris County Municipal Utility
3 District No. 465.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 2, Chapter 465, Acts of the 79th
6 Legislature, Regular Session, 2005, is amended to read as follows:

7 Sec. 2. The Harris County Municipal Utility District No.
8 465 [~~initially~~] includes all the territory contained in the
9 following area:

10 Being 320.794 acres of land located in the A. E. Spencer
11 Survey, Abstract 1365, and the W. B. Macomer Survey, Abstract 1528,
12 the L. Breeding Survey, Abstract 1468, and the C. Breeding Survey,
13 Abstract 1467, Harris County, Texas, being a portion of that
14 certain called 315.38 acre tract (Tract I) and the residue of that
15 certain called 19.768 acre tract (Tract III) by an instrument of
16 record in File Number D990282, Official Public Records of Real
17 Property, Harris County, Texas, (H.C.O.P.R.R.P.), said 320.794
18 acres being more particularly described by metes and bounds as
19 follows, all bearings based upon the west line of said 315.38 acre
20 tract, and being north (called north);

21 BEGINNING on the common line of said W. B. Macomer Survey,
22 Abstract 1528, and the H. & T.C. Railroad Company Survey Section 87,
23 Abstract 455 of said Harris County, Texas, at its intersection with
24 the north right-of-way line of F. M. Highway 529, said point being

1 the southwest corner of said 315.38 acre tract;

2 Thence, North (called North) along the common line of said W.
3 B. Macomer Survey and said H. & T.C. Railroad Company Survey,
4 5,204.14 feet to the northwest corner of the herein described
5 tract, the northwest corner of said 315.38 acre tract, same being
6 the northeast corner of a called 21.157 acre tract by an instrument
7 of record in File Number P040350, H.C.O.P.R.R.P., on the south
8 right-of-way line of Longenbaugh Road;

9 Thence, North 89° 59' 17" East, along the north line of the
10 herein described tract and the north line of said 315.38 acre tract,
11 and the south right-of-way line of said Longenbaugh Road, 2,640.00
12 feet to the northeast corner of the herein described tract and the
13 northeast corner of said 315.38 acre tract, same being the
14 northwest corner of the residue of a called 510.63 acre tract by an
15 instrument of record in Volume 1270, Page 473, and Volume 1267, Page
16 163, Deed Records of said Harris County, Texas (H.C.D.R.);

17 Thence, South (called South) along the east line of the
18 herein described tract and the east line of said called 315.38 acre
19 tract, same being the west line of said adjoining residue of a
20 called 510.63 acre tract, at 2,613.77 feet pass a point on said line
21 at its intersection with the south line of the A. E. Spencer Survey,
22 Abstract 1365, said point being the southwest corner of said
23 adjoining residue of a called 510.63 acre tract, same being the
24 northwest corner of an adjoining called 73.718 acre tract described
25 in deed recorded under County Clerk's File Numbers L9788401,
26 N447931, N447932, and W740505, Official Public Records of Real
27 Property, Harris County, Texas, said point also being the northwest

1 corner of the L. Breeding Survey, Abstract 1468, same being the
2 northeast corner of the W. B. Macomer Survey, Abstract 1528, and
3 continuing for a total distance of 3,844.35 feet to a reentry corner
4 to the herein described tract, same being the southwest corner of
5 said adjoining called 73.718 acre tract;

6 Thence, North 89 degrees 57 minutes 16 seconds East (adjoiner
7 called East) along the lower north line of the herein described
8 tract, same being the south line of said adjoining called 73.718
9 acre tract, 2,609.39 feet (adjoiner called 2,609.44 feet) to a
10 northeast corner of the herein described tract, same being the
11 southeast corner of said adjoining called 73.718 acre tract, and
12 being in the west right-of-way line of Katy Hockley Road;

13 Thence, South 00 degrees 01 minute 11 seconds East (called
14 South) along the middle east line the herein described tract and the
15 east line of said residue of a called 19.768 acre tract, same being
16 the west right-of-way line of Katy Hockley Road, 90.00 feet to a
17 southeast corner of the herein described tract and the southeast
18 corner of said called 19.768 acre tract, same being the northeast
19 corner of an adjoining called 1.00 acre tract described in deed
20 recorded under County Clerk's File Number T395128, Official Public
21 Records of Real Property, Harris County, Texas, said point also
22 being the southeast corner of the C. Breeding Survey, Abstract
23 1467, same being the lower northeast corner of the L. Breeding
24 Survey, Abstract 1468;

25 Thence, South 89 degrees 57 minutes 16 seconds West along the
26 south line of the C. Breeding Survey, Abstract 1467, same being the
27 lower north line of the L. Breeding Survey, Abstract 1468, being the

1 upper south line of the herein described tract and the south line of
2 said called 19.768 acre tract, same being the north line of said
3 adjoining called 1.00 acre tract, and along the north line of an
4 adjoining called 1.9578 acre tract described in deed recorded under
5 County Clerk's File Number T233387, Official Public Records of Real
6 Property, Harris County, Texas, the north line of an adjoining
7 called 13.9559 acre tract described in deed recorded under County
8 Clerk's File Number G594514, Official Public Records of Real
9 Property, Harris County, Texas, the north line of an adjoining
10 called 13.955 acre tract described in deed recorded under County
11 Clerk's File Number H415235, Official Public Records of Real
12 Property, Harris County, Texas, the north line of an adjoining
13 called 3.955 acre tract described in deed recorded under County
14 Clerk's File Number G067328, Official Public Records of Real
15 Property, Harris County, Texas, and the north line of an adjoining
16 called 10 acre tract described in deed recorded under County
17 Clerk's File Number D745445, Official Public Records of Real
18 Property, Harris County, Texas, the north line of an adjoining
19 called 10 acre tract described in deed recorded under County
20 Clerk's File Number H755391, Official Public Records of Real
21 Property, Harris County, Texas, the north line of an adjoining
22 called 10 acre tract described in deed recorded under County
23 Clerk's File Number H956910, Official Public Records of Real
24 Property, Harris County, Texas, for a total distance of 2,610.82
25 feet (called 2,609.44 feet) to a reentry corner to the herein
26 described tract, same being the occupied northwest corner of said
27 adjoining called 10 acre tract (County Clerk's File Number

1 H956910), said point also being in the occupied common line of the
2 L. Breeding Survey, Abstract 1468, and the W. B. Macomer Survey,
3 Abstract 1528;

4 Thence, South 00 degrees 03 minutes 48 seconds East (called
5 South) along the occupied common line of the herein described tract
6 and said adjoining called 10 acre tract, 1,269.78 feet to a
7 southeast corner of said called 315.38 acre tract, same being the
8 southwest corner of said adjoining called 10 acre tract, and being
9 in the north right-of-way line of F. M. Highway 529;

10 Thence, North 89 degrees 59 minutes 17 seconds West (called
11 West) along the lower south line of the herein described tract and
12 the south line of said called 315.38 acre tract, same being the
13 north right-of-way line of F. M. Highway 529, 2,640.00 feet (called
14 2,640 feet) to the Place of Beginning and containing 320.794 acres
15 of land, more or less.

24 SECTION 2. (a) The Harris County Municipal Utility
25 District No. 465 retains all rights, powers, privileges, authority,
26 duties, and functions that it had before the effective date of this
27 Act.

1 (b) Notwithstanding any other law, the Harris County
2 Municipal Utility District No. 465 may continue to rely on any bond
3 election held before the effective date of this Act.

4 SECTION 3. (a) Any act or proceeding of the district,
5 including an election, not excepted by this section and taken
6 before the effective date of this Act, is validated and confirmed in
7 all respects.

8 (b) This section does not apply to:

9 (1) an act, proceeding, director, other official,
10 bond, or other obligation the validity of which or of whom is the
11 subject of litigation that is pending on the effective date of this
12 Act; or

13 (2) an act or proceeding that, under a statute of this
14 state or the United States, was a misdemeanor or felony at the time
15 the act or proceeding occurred.

16 SECTION 4. (a) The legal notice of the intention to
17 introduce this Act, setting forth the general substance of this
18 Act, has been published as provided by law, and the notice and a
19 copy of this Act have been furnished to all persons, agencies,
20 officials, or entities to which they are required to be furnished
21 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
22 Government Code.

23 (b) The governor, one of the required recipients, has
24 submitted the notice and Act to the Texas Commission on
25 Environmental Quality.

26 (c) The Texas Commission on Environmental Quality has filed
27 its recommendations relating to this Act with the governor, the

1 lieutenant governor, and the speaker of the house of
2 representatives within the required time.

3 (d) All requirements of the constitution and laws of this
4 state and the rules and procedures of the legislature with respect
5 to the notice, introduction, and passage of this Act are fulfilled
6 and accomplished.

7 SECTION 5. This Act takes effect September 1, 2015.
