1-17 A BILL TO BE ENTITLED
1-18 AN ACT

1-19 relating to the establishment of an infrastructure improvement
1-20 council by the Rio Grande Regional Water Authority; providing
1-21 authority to impose a voluntary assessment.

1-22 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-23 SECTION 1. Section 1.01, Chapter 385, Acts of the 78th
1-24 Legislature, Regular Session, 2003, is amended by adding
1-25 Subdivision (4-b) to read as follows:

1-26 (4-b) "Council" means the council established under
1-27 Section 1B.01 of this Act.

1-28 SECTION 2. Chapter 385, Acts of the 78th Legislature,
1-29 Regular Session, 2003, is amended by adding Article IB to read as
1-30 follows:

1-31 ARTICLE IB. INFRASTRUCTURE IMPROVEMENT COUNCIL

1-32 Sec. 1B.01. INFRASTRUCTURE IMPROVEMENT COUNCIL. (a) The
1-33 board shall establish an infrastructure improvement council in
1-34 connection with the implementation of infrastructure improvement
1-35 projects within the authority's territory.

1-36 (b) The board shall set, according to a formula determined
1-37 by the board, an annual voluntary assessment. Revenue from the
1-38 assessment imposed under this subsection shall be deposited to the
1-39 credit of an infrastructure improvement fund to be administered by
1-40 the council. After the board sets the formula used to determine the
1-41 assessment, the assessment may be modified only by the council.

1-42 (c) A member of the conference that pays the voluntary
1-43 assessment under Subsection (b) shall appoint a representative to
1-44 serve as a member of the council.

1-45 (d) The council may apply for financial assistance under
1-46 Subchapters G and H, Chapter 15, Water Code, and may implement
1-47 infrastructure improvement projects approved by the council under
1-48 this article.

1-49 (e) The council shall study the viability of each
1-50 infrastructure improvement project requested by council members to
1-51 determine whether an infrastructure improvement project is
1-52 eligible to receive financial assistance from the council.

1-53 (f) Only members of the council are eligible to receive
1-54 financial assistance from the council for infrastructure
1-55 improvement projects under this article.

1-56 (g) The council shall establish procedures to govern the
1-57 council.

1-58 (h) The council may:

1-59 (1) hire employees to implement this section; and

1-60 (2) engage in infrastructure improvement projects

2-1 without board approval.

2-2 SECTION 3. This Act takes effect September 1, 2015.
