## A BILL TO BE ENTITLED

1	AN ACT	

- 2 relating to the electronic filing of reports of political
- 3 contributions and expenditures and of personal financial
- 4 statements by certain officeholders and candidates and the content
- 5 of those statements; creating a criminal offense.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 7 SECTION 1. Section 254.036, Election Code, is amended by
- 8 adding Subsection (f-1) to read as follows:
- 9 <u>(f-1)</u> A report filed under this chapter with an authority
- 10 other than the commission may be filed electronically by using
- 11 computer software developed by the commission, if the authority
- 12 with whom the report is required to be filed has adopted rules and
- 13 procedures to provide for the filing of the report using the
- 14 software.
- 15 SECTION 2. Section 571.0671, Government Code, is amended to
- 16 read as follows:
- 17 Sec. 571.0671. REQUIREMENTS FOR ELECTRONIC FILING
- 18 SOFTWARE. (a) Computer software provided or approved by the
- 19 commission for use under Section 254.036(b), Election Code, or
- 20 Section 302.013, [er] 305.0064, or 572.0291 must:
- 21 (1) use a standardized format for the entry of names,
- 22 addresses, and zip codes;
- 23 (2) provide for secure and encoded transmission of
- 24 data from the computer of a person filing a report to the computers

- 1 used by the commission;
- 2 (3) be capable of being used by a person with basic
- 3 computing skills;
- 4 (4) provide confirmation to a person filing a report
- 5 that the report was properly received; and
- 6 (5) permit a person using a computer to prepare a
- 7 report or to retrieve information from a report to import
- 8 information to the report from a variety of computer software
- 9 applications that meet commission specifications for a standard
- 10 file format or export information from the report to a variety of
- 11 computer software applications that meet commission specifications
- 12 for a standard file format without the need to reenter information.
- 13 (b) Before determining the specifications for computer
- 14 software developed, purchased, or licensed for use under Section
- 15 254.036, Election Code, or Section 302.013, [or] 305.0064, or
- 16 572.0291, the commission shall conduct at least one public hearing
- 17 to discuss the specifications. For at least 10 days following the
- 18 hearing, the commission shall accept public comments concerning the
- 19 software specifications.
- 20 (c) The commission may provide software for use under
- 21 Section 254.036(b), Election Code, or Section 302.013, [or]
- 22 305.0064, or 572.0291 by making the software available on the
- 23 Internet. If the commission makes the software available on the
- 24 Internet, the commission is not required to provide the software on
- 25 computer diskettes, CD-ROMs, or other storage media without charge
- 26 to persons required to file reports under that section, but may
- 27 charge a fee for providing the software on storage media. A fee

- 1 under this subsection may not exceed the cost to the commission of
- 2 providing the software.
- 3 SECTION 3. Section 572.023, Government Code, is amended by
- 4 adding Subsections (f) and (g) to read as follows:
- 5 (f) Each financial statement filed with a filing authority
- 6 other than the commission that is not filed electronically must be
- 7 accompanied by an affidavit executed by the person required to file
- 8 the financial statement. The affidavit must contain the statement:
- 9 "I swear, or affirm, under penalty of perjury, that the
- 10 accompanying financial statement is true and correct and includes
- 11 all information required to be reported by me under Chapter 572 of
- 12 the Government Code." A financial statement filed under this
- 13 chapter is considered to be under oath by the person required to
- 14 file the financial statement, and the person is subject to
- 15 prosecution under Chapter 37, Penal Code, regardless of the absence
- 16 of or a defect in the affidavit.
- 17 (g) A person who electronically files a financial statement
- 18 with the commission or another filing authority is not required to
- 19 include a notarized affidavit with the financial statement if the
- 20 person:
- 21 (1) has requested and received an electronic filing
- 22 password pursuant to the rules of the commission or other
- 23 <u>authority</u>, as applicable; and
- 24 (2) uses that password to file the financial
- 25 statement.
- SECTION 4. Subchapter B, Chapter 572, Government Code, is
- 27 amended by adding Section 572.0291 to read as follows:

- 1 Sec. 572.0291. ELECTRONIC FILING REQUIRED. A financial
- 2 statement filed with the commission must be filed by computer
- 3 diskette, modem, or other means of electronic transfer, using
- 4 computer software provided by the commission or computer software
- 5 that meets commission specifications for a standard file format.
- 6 SECTION 5. Section 145.004, Local Government Code, is
- 7 amended by adding Subsection (h) to read as follows:
- 8 (h) A financial statement filed under this chapter may be
- 9 filed electronically by using computer software developed by the
- 10 Texas Ethics Commission if the clerk or secretary of the
- 11 municipality with whom the statement is required to be filed has
- 12 adopted rules and procedures to provide for the filing of the
- 13 statement using the software.
- 14 SECTION 6. Section 159.004(f), Local Government Code, is
- 15 amended to read as follows:
- 16 (f) A county clerk may adopt rules and procedures under this
- 17 section relating only to the manner in which a person must
- 18 electronically file a financial statement and the required format
- 19 of an electronically filed statement. Those rules may allow a
- 20 person to file a statement electronically by using computer
- 21 software developed by the Texas Ethics Commission.
- SECTION 7. Section 159.0341(b), Local Government Code, is
- 23 amended to read as follows:
- (b) An officer with whom a report is required to be filed
- 25 under this subchapter may adopt rules and procedures under this
- 26 section relating only to the manner in which a person must
- 27 electronically file a report and the required format of an

- 1 electronically filed report. Those rules may allow a person to file
- 2 a report electronically by using computer software developed by the
- 3 Texas Ethics Commission.
- 4 SECTION 8. Section 159.053, Local Government Code, is
- 5 amended by adding Subsection (d) to read as follows:
- 6 (d) A financial statement filed under this subchapter may be
- 7 filed electronically by using computer software developed by the
- 8 commission if the county clerk with whom the statement is required
- 9 to be filed has adopted rules and procedures to provide for the
- 10 filing of the statement using the software.
- 11 SECTION 9. Section 572.023, Government Code, as amended by
- 12 this Act, applies only to a financial statement due on or after the
- 13 effective date of this Act. A financial statement due before the
- 14 effective date of this Act is governed by the law in effect on the
- 15 date the financial statement was due, and the former law is
- 16 continued in effect for that purpose.
- 17 SECTION 10. This Act takes effect September 1, 2015.
