| 15 | ACCOUNT. (a) The emergency medical air transportation account is |
| 16 | established as a dedicated account in the general revenue fund. The |
| 17 | account is composed of: |
| 18 | (1) money deposited to the credit of the account under |
| 19 | Section 542.4031, Transportation Code; and |
| 20 | (2) notwithstanding Section 404.071, Government Code, |
| 21 | interest earned on the investment of money in the account and |

- 2 (1) use the money appropriated from the account to

- 7 (A) provide reimbursements under the medical
- 8 <u>assistance program under Chapter 32, Human Resources Code, to</u>
- 9 providers of emergency medical air transportation services,
- 10 including reimbursement enhancements to the statewide dollar
- 11 amount rate used to reimburse designated air ambulance services
- 12 under the program; and
- 13 (B) maximize the receipt of federal funds under

- SECTION 2. Section 542.4031(g), Transportation Code, is
- 17 amended to read as follows:
- 18 (g) Of the money received by the comptroller under this
- 19 section, the comptroller shall deposit:
- 20 (1) 67 percent to the credit of the undedicated
- 21 portion of the general revenue fund; [and]
- (2) $\underline{16.5}$ [33] percent to the credit of the designated
- 23 trauma facility and emergency medical services account under
- 24 Section 780.003, Health and Safety Code; and
- 25 (3) 16.5 percent to the credit of the designated
- 26 emergency medical air transportation account under Section
- 27 773.222, Health and Safety Code.

- SECTION 3. Section 542.4031(g), Transportation Code, as amended by this Act, applies only to the distribution of revenue collected on or after the effective date of this Act. The distribution of revenue collected before the effective date of this Act is governed by the law in effect at the time the revenue was collected, and that law is continued in effect for the purpose of the distribution of that revenue.
- 8 SECTION 4. This Act takes effect September 1, 2015.
