- 2 Sec. 292.003. COUNTY HEALTH CARE PROVIDER PARTICIPATION
- 3 PROGRAM; PARTICIPATION IN PROGRAM. (a) A county health care
- 4 provider participation program authorizes a county to collect a
- 5 mandatory payment from each institutional health care provider
- 6 located in the county to be deposited in a local provider
- 7 participation fund established by the county. Money in the fund may
- 8 be used by the county to fund certain intergovernmental transfers
- 9 and indigent care programs as provided by this chapter.
- 10 (b) The commissioners court may adopt an order authorizing a

SUBCHAPTER D. MANDATORY PAYMENTS

- Sec. 292.151. MANDATORY PAYMENTS BASED ON PAYING HOSPITAL 8 NET PATIENT REVENUE. (a) Except as provided by Subsection (e), 9 the commissioners court of a county that collects a mandatory 10 11 payment authorized under this chapter may require an annual mandatory payment to be assessed on the net patient revenue of each 12 13 institutional health care provider located in the county. commissioners court may provide for the mandatory payment to be 14 assessed quarterly. In the first year in which the mandatory 15 payment is required, the mandatory payment is assessed on the net 16 patient revenue of an institutional health care provider as 17 determined by the data reported to the Department of State Health 18 Services under Sections 311.032 and 311.033 in the fiscal year 19 20 ending in 2013 or, if the institutional health care provider did not report any data under those sections in that fiscal year, as 21
- 22 <u>determined by the institutional health care provider's Medicare</u>
- 23 cost report submitted for the 2013 fiscal year or for the closest
- 24 subsequent fiscal year for which the provider submitted the
- 25 Medicare cost report. The county shall update the amount of the
- 26 mandatory payment on an annual basis.
- 27 (b) The amount of a mandatory payment authorized under this

- 1 chapter must be uniformly proportionate with the amount of net
- 2 patient revenue generated by each paying hospital in the county. A
- 3 mandatory payment authorized under this chapter may not hold
