- SECTION 2. Section 11.1272, Water Code, is amended by

- 18 plan and submit to the commission the reviewed or updated plan.
- 19 <u>(g)</u> A wholesale water supplier, a retail public water
- 20 supplier that provides potable water service to 3,300 or more

- SECTION 3. Subchapter C, Chapter 16, Water Code, is amended

- 25 (b) The board, in coordination with the commission and the

- 8 SECTION 4. As soon as practicable after the effective date

- 10 adopt rules as necessary to implement Section 11.1272, Water Code,
- 11 as amended by this Act.
- 12 SECTION 5. This Act takes effect September 1, 2015.
