1 <u>attorney general or a state agency represented by the attorney</u> 2 <u>general is named as an in rem defendant in the underlying suit for</u> 3 <u>seizure of the property or foreclosure of a tax lien on the</u> 4 <u>property</u>.

5 SECTION 2. The change in law made by this Act applies to the 6 disposition of excess proceeds of a property tax foreclosure sale paid into court regardless of the date on which the foreclosure sale 7 8 occurred or the date on which the proceeds were paid into the court. 9 If on the effective date of this Act the clerk of a court is retaining excess proceeds and Section 34.03(a)(3), Tax Code, as 10 added by this Act, applies, the clerk shall mail the notice required 11 by that subdivision as soon as practicable after the effective date 12 of this Act. The clerk may not distribute those proceeds as provided 13 14 by Section 34.03(b), Tax Code, before the second anniversary of the 15 date the notice is mailed. A claim for the proceeds made on or before that second anniversary is considered to have been made 16 17 within the period provided by Section 34.03(b), Tax Code.
