4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Section 437.001, Health and Safety Code, is
6	amended by adding Subdivisions (1-a) and (7) to read as follows:
7	(1-a) "Beekeeper" has the meaning assigned by Section
8	131.001, Agriculture Code.
9	(7) "Small honey production operation" means a
10	beekeeper that:
11	(A) produces less than 2,500 pounds of honey each
12	year;
13	(B) sells or distributes the honey or honeycomb
14	that the beekeeper produces either personally or with the help of
15	the beekeeper's immediate family members;
16	(C) only sells or distributes honey or honeycomb:
17	(i) that is produced from a hive that is:
18	(a) located in the state; and
19	(b) owned and managed by the
20	beekeeper;
21	(ii) that is pure honey as defined by
22	Section 131.001, Agriculture Code, and that is raw and not blended
23	with any other product or otherwise adulterated; and
24	(iii) directly to consumers at the

- 1 beekeeper's home, a farmer's market, a farm stand, or a municipal,
- 2 county, or nonprofit fair, festival, or event; and
- 3 (D) delivers the honey or honeycomb that the
- 4 beekeeper produces to the consumer at the point of sale or another
- 5 <u>location designated by the consumer.</u>
- 6 SECTION 2. Chapter 437, Health and Safety Code, is amended
- 7 by adding Sections 437.0197, 437.0198, and 437.0199 to read as
- 8 follows:
- 9 Sec. 437.0197. EXEMPTION FOR SMALL HONEY PRODUCTION
- 10 OPERATION. A small honey production operation is not a food service
- 11 establishment for purposes of this chapter.
- 12 Sec. 437.0198. REGULATION OF SMALL HONEY PRODUCTION
- 13 OPERATION PROHIBITED. A local government authority, including a
- 14 local health department, may not regulate the production of honey
- 15 or honeycomb at a small honey production operation.
- Sec. 437.0199. LABELING REQUIREMENTS FOR SMALL HONEY
- 17 PRODUCTION OPERATION. Honey or honeycomb sold or distributed by a
- 18 small honey production operation must be labeled in accordance with
- 19 <u>Subchapter E, Chapter 131, Agriculture Code. The label must</u>
- 20 include:
- 21 (1) the net weight of the honey expressed in both the
- 22 avoirdupois and metric systems;
- 23 (2) the beekeeper's name and address; and
- 24 (3) the statement "Bottled or packaged in a facility
- 25 not inspected by the Texas Department of State Health Services."
- 26 SECTION 3. This Act takes effect September 1, 2015.
