BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
SECTION 1. Section 403.023, Government Code, is amended by
adding Subsections (b-1) and (b-2) to read as follows:
(b-1) Except as provided by Subsection (b-2), if the
comptroller adopts rules authorized under Subsection (b), the rules
<u>must:</u>
(1) require a state agency in the executive branch of
state government to use a credit or charge card to pay for all
purchases unless the comptroller determines that another method of
payment is more advantageous to the state; and
(2) prohibit an employee of a state agency in the
executive branch of state government from using a personal credit
or charge card to pay for the state agency's purchases.
(b-2) Subsection (b-1) does not apply to:
(1) an institution of higher education as defined by
Section 61.003, Education Code; or
(2) the office of the governor.
SECTION 2. Section 660.021, Government Code, is amended to
read as follows:
Sec. 660.021. RULES. <u>(a)</u> The comptroller shall adopt rules
for the effective and efficient administration of this chapter and
