A BILL TO BE ENTITLED

1	AN ACT

- 2 relating to authorizing supported decision-making agreements for
- 3 certain adults with disabilities.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subtitle I, Title 3, Estates Code, is amended by
- 6 adding Chapter 1357 to read as follows:
- 7 CHAPTER 1357. SUPPORTED DECISION-MAKING AGREEMENT ACT
- 8 SUBCHAPTER A. GENERAL PROVISIONS
- 9 Sec. 1357.001. SHORT TITLE. This chapter may be cited as
- 10 the Supported Decision-Making Agreement Act.
- 11 Sec. 1357.002. DEFINITIONS. In this chapter:
- 12 (1) "Adult" means an individual 18 years of age or
- 13 older or an individual under 18 years of age who has had the
- 14 <u>disabilities of minority removed.</u>
- 15 (2) "Disability" means, with respect to an individual,
- 16 a physical or mental impairment that substantially limits one or
- 17 more major life activities.
- 18 (3) "Supported decision-making" means a process of
- 19 supporting and accommodating an adult with a disability to enable
- 20 the adult to make life decisions, including decisions related to
- 21 where the adult wants to live, the services, supports, and medical
- 22 care the adult wants to receive, whom the adult wants to live with,
- 23 and where the adult wants to work, without impeding the
- 24 self-determination of the adult.

1 (4) "Supported decision-making agreement" is an 2 agreement between an adult with a disability and a supporter 3 entered into under this chapter. 4 (5) "Supporter" means an adult who has entered into a 5 supported decision-making agreement with an adult with a 6 disability. 7 Sec. 1357.003. PURPOSE. The purpose of this chapter is to 8 recognize a less restrictive alternative to quardianship for adults 9 with disabilities who need assistance with decisions regarding daily living but who are not considered incapacitated persons for 10 11 purposes of establishing a guardianship under this title. SUBCHAPTER B. SCOPE OF AGREEMENT AND AGREEMENT REQUIREMENTS 12 13 Sec. 1357.051. SCOPE OF SUPPORTED DECISION-MAKING AGREEMENT. An adult with a disability may voluntarily, without 14 undue influence or coercion, enter into a supported decision-making 15 agreement with a supporter under which the adult with a disability 16 17 authorizes the supporter to do any or all of the following: 18 (1) provide supported decision-making, including assistance in understanding the options, responsibilities, and 19 20 consequences of the adult's life decisions, without making those decisions on behalf of the adult with a disability; 21 22 (2) subject to Section 1357.054, assist the adult in accessing, collecting, and obtaining information that is relevant 23 to a given life decision, including medical, psychological, 24 25 financial, educational, or treatment records, from any person; (3) assist the adult with a disability in 26

understanding the information described by Subdivision (2); and

- 1 (4) assist the adult in communicating the adult's
- 2 decisions to appropriate persons.
- 3 Sec. 1357.052. AUTHORITY OF SUPPORTER. A supporter may
- 4 exercise the authority granted to the supporter in the supported
- 5 <u>decision-making agreement.</u>
- 6 Sec. 1357.053. TERM OF AGREEMENT. (a) Except as provided
- 7 by Subsection (b), the supported decision-making agreement extends
- 8 until terminated by either party or by the terms of the agreement.
- 9 <u>(b) The supported decision-making agreement is terminated</u>
- 10 if:
- 11 (1) the Department of Family and Protective Services
- 12 finds that the adult with a disability has been abused, neglected,
- 13 or exploited by the supporter; or
- 14 (2) the supporter is found criminally liable for
- 15 conduct described by Subdivision (1).
- Sec. 1357.054. ACCESS TO PERSONAL INFORMATION. (a) A
- 17 supporter is only authorized to assist the adult with a disability
- 18 in accessing, collecting, or obtaining information that is relevant
- 19 to a decision authorized under the supported decision-making
- 20 agreement.
- 21 (b) If a supporter assists an adult with a disability in
- 22 accessing, collecting, or obtaining personal information,
- 23 including protected health information under the Health Insurance
- 24 Portability and Accountability Act of 1996 (Pub. L. No. 104-191) or
- 25 educational records under the Family Educational Rights and Privacy
- 26 Act of 1974 (20 U.S.C. Section 1232g), the supporter shall ensure
- 27 the information is kept privileged and confidential, as applicable,

1	and is not subject to unauthorized access, use, or disclosure.
2	(c) The existence of a supported decision-making agreement
3	does not preclude an adult with a disability from seeking personal
4	information without the assistance of a supporter.
5	Sec. 1357.055. AUTHORIZING AND WITNESSING OF SUPPORTED
6	DECISION-MAKING AGREEMENT. (a) A supported decision-making
7	agreement must be signed voluntarily, without coercion or undue
8	influence, by the adult with a disability and the supporter in the
9	presence of two or more subscribing witnesses or a notary public.
10	(b) If signed before two witnesses, the attesting witnesses
11	must be at least 14 years of age.
12	Sec. 1357.056. FORM OF SUPPORTED DECISION-MAKING
13	AGREEMENT. (a) Subject to Subsection (b), a supported
14	decision-making agreement is valid only if it is in substantially
15	the following form:

15	records under the Family Educational Rights and Privacy Act of 1974
16	(20 U.S.C. Section 1232g) is attached.

7	(b) A supported decision-making agreement may be in any form

- 1 not inconsistent with Subsection (a) and the other requirements of
- 2 this chapter.
- 3 SUBCHAPTER C. DUTY OF CERTAIN PERSONS WITH RESPECT TO AGREEMENT
- 4 Sec. 1357.101. RELIANCE ON AGREEMENT; LIMITATION OF
- 5 LIABILITY. (a) A person who receives the original or a copy of a
- 6 supported decision-making agreement shall rely on the agreement.
- 7 (b) A person is not subject to criminal or civil liability
- 8 and has not engaged in professional misconduct for an act or
- 9 omission if the act or omission is done in good faith and in
- 10 reliance on a supported decision-making agreement.
- 11 Sec. 1357.102. REPORTING OF SUSPECTED ABUSE, NEGLECT, OR
- 12 EXPLOITATION. If a person who receives a copy of a supported
- 13 decision-making agreement or is aware of the existence of a
- 14 supported decision-making agreement has cause to believe that the
- 15 adult with a disability is being abused, neglected, or exploited by
- 16 the supporter, the person shall report the alleged abuse, neglect,
- 17 <u>or exploitation to the Department of Family and Protective Services</u>
- 18 in accordance with Section 48.051, Human Resources Code.
- 19 SECTION 2. This Act takes effect immediately if it receives
- 20 a vote of two-thirds of all the members elected to each house, as
- 21 provided by Section 39, Article III, Texas Constitution. If this
- 22 Act does not receive the vote necessary for immediate effect, this
- 23 Act takes effect September 1, 2015.
