4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Chapter 42, Parks and Wildlife Code, is amended
6	by adding Section 42.011 to read as follows:
7	Sec. 42.011. VOLUNTARY CONTRIBUTION TO HELP FEED HUNGRY
8	TEXANS. (a) When a person applies for a hunting license of any
9	type under this chapter, the person may contribute \$1 or more to a
10	nonprofit organization, designated by the commission, whose
11	purposes include the administration of a statewide program that
12	provides hunters with a way to donate legally harvested deer to
13	local food assistance providers. The program must include the
14	recruitment of meat processors who, for a nominal fee to cover
15	processing costs, process and package the venison and contact the
16	food assistance providers to pick up the venison.
17	(b) The department shall:
18	(1) include space on each application for a hunting
19	license that allows a person applying for the license to indicate
20	the amount that the person is voluntarily contributing to the
21	nonprofit organization; and
22	(2) provide an opportunity for a person to contribute
23	to the nonprofit organization during the application process for a
24	hunting license on the department's Internet website.

1	(c) After deducting the department's administrative costs,
2	the department shall hold in trust the remainder of the amount a
3	person contributes under this section to the nonprofit
4	organization. Not later than November 1 of each year, the
5	department shall send the money held in trust to the nonprofit
6	organization.
7	(d) Money received by the nonprofit organization under this
8	section may be used only to administer, operate, support, and
9	promote the program described by Subsection (a).
10	(e) The nonprofit organization shall submit an annual
11	report to the legislature and the department that includes the
12	total dollar amount of contributions received by the organization
13	under this section.
14	(f) The commission may adopt rules to implement this
15	section, including rules related to processes for the selection,
16	inspection, and periodic review of the nonprofit organization.
17	SECTION 2. The commission shall designate a nonprofit
18	organization to receive the donations under Section 42.011, Parks
19	and Wildlife Code, as added by this Act, not later than September
20	15, 2015.

SECTION 3. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2015.
