- 4 SECTION 1. Section 1802.002(a), Occupations Code, is
- 5 amended to read as follows:
- 6 (a) This chapter does not apply to:
- 7 (1) a sale conducted by order of a United States court
- 8 under Title 11, United States Code;
- 9 (2) a sale conducted by an employee of the United
- 10 States, this state, or a political subdivision of this state in the
- 11 course and scope of employment;
- 12 (3) a sale conducted by a charitable, religious, or
- 13 civic organization, including an organization having a tax exempt
- 14 status under Section 501(c), Internal Revenue Code of 1986, or
- 15 organized as a nonprofit entity, if the person organizing,
- 16 arranging, or conducting the auction receives no compensation;
- 17 (4) a sale conducted by any person of the person's
- 18 property if the person is not engaged in the business of selling
- 19 property at auction on a recurring basis;
- 20 (5) a foreclosure sale of real property personally
- 21 conducted by a trustee under a deed of trust;
- 22 (6) a foreclosure sale of personal property personally
- 23 conducted by:
- 24 (A) a person who holds a security interest in the

- 1 property, including a mortgage; or
- 2 (B) an employee or agent of a person described by
- 3 Paragraph (A) acting in the course and scope of employment, if:
- 4 (i) the employee or agent is not otherwise
- 5 engaged in the auction business; and
- 6 (ii) all property for sale in the auction is
- 7 subject to a security agreement;
- 8 (7) a sale conducted by sealed bid without the option
- 9 of increasing or decreasing the amount of a bid;
- 10 (8) an auction conducted only for student training
- 11 purposes as part of a course of study approved by the department;
- 12 (9) an auction conducted by a posted stockyard or
- 13 market agency as defined by the federal Packers and Stockyards Act
- 14 (7 U.S.C. Section 181 et seq.), as amended;
- 15 (10) an auction of livestock conducted by a nonprofit
- 16 livestock trade association chartered in this state, if the auction
- 17 involves only the sale of livestock owned by members of the trade
- 18 association;
- 19 (11) an auction conducted by a charitable or nonprofit
- 20 organization chartered in this state, if the auction:
- 21 (A) is part of a fair that is organized under
- 22 state, county, or municipal authority; and
- 23 (B) involves only the sale of property owned by
- 24 the organization's members; [or]
- 25 (12) a sale or auction conducted outside of this
- 26 state;
- 27 (13) a sale of motor vehicles at auction by a person

- 1 licensed under Chapter 2301 or 2302; or
- 2 (14) a sale of motor vehicles at auction by a person
- 3 who holds a wholesale motor vehicle auction general distinguishing
- 4 <u>number or an independent motor vehicle</u> general distinguishing
- 5 number issued by the Texas Department of Motor Vehicles.
- 6 SECTION 2. Section 1802.051, Occupations Code, is amended
- 7 by amending Subsection (c) and adding Subsection (d) to read as
- 8 follows:
- 9 (c) Except as provided by Subsection (d), an [An] individual
- 10 who is licensed under this chapter may not act as an auctioneer for
- 11 an entity unless the entity:
- 12 (1) is an auction company owned or operated by an
- 13 individual who is licensed under this chapter; or
- 14 (2) [holds a dealer general distinguishing number
- 15 issued under Subchapter B, Chapter 503, Transportation Code, and
- 16 the auction is for the purpose of auctioning vehicles as defined by
- 17 Section 503.001, Transportation Code; or
- 18 [<del>(3)</del>] is a real estate brokerage firm that is operated
- 19 by a broker licensed by the Texas Real Estate Commission.
- 20 (d) An individual who is licensed under this chapter may
- 21 conduct an auction to sell motor vehicles, as defined by Section
- 22 <u>501.002</u> or <u>502.001</u>, Transportation Code, if the individual conducts
- 23 the auction for a person who holds a dealer general distinguishing
- 24 <u>number or wholesale motor vehicle auction general distinguishing</u>
- 25 number issued under Subchapter B, Chapter 503, Transportation Code,
- or a license issued under Subchapter C, Chapter 2302, of this code.
- 27 SECTION 3. This Act takes effect immediately if it receives
