S.B. No. 2047

A BILL TO BE ENTITLED

1 AN ACT
2 relating to the territory included in, the composition of the board
3 of directors of, and the powers of the Harris County Improvement
4 District No. 17.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

6 SECTION 1. Subchapter C, Chapter 3891, Special District
7 Local Laws Code, is amended by adding Section 3891.109 to read as
8 follows:

9 Sec. 3891.109. ENFORCEMENT OF REAL PROPERTY RESTRICTIONS.
10 Section 54.237, Water Code, applies to the district.

11 SECTION 2. (a) On the later of June 1, 2015, or the
12 effective date of this Act, the board of directors of the Harris
13 County Improvement District No. 17 is dissolved.

14 (b) On the effective date of this Act, the board of
15 directors of the Harris County Improvement District No. 17 is
16 reconstituted and is composed of the following directors:

23 (c) The terms of the directors in positions 1, 2, and 3
24 expire June 1, 2017.

1 (d) The terms of the directors in positions 4 and 5 expire
2 June 1, 2019.

3 (e) The Harris County Commissioners Court shall appoint
4 successor directors as provided by Section 3891.052, Special
5 District Local Laws Code.

6 SECTION 3. The following territory is added to the
7 territory of the Harris County Improvement District No. 17:

8 HARRIS COUNTY:

9 Tract 1 (FM 2920 and Telge) is +/- 117 acres in size, within the W.
10 Hurd Survey (Abstract No. 377) and situated southwest of the
11 intersection of Farm-to-Market 2920 (Waller-Tomball) and Telge
12 Roads in northwest Harris County with point of beginning being
13 northeast corner of 111 tract (ABST 377W HURD TRS 3C 3D 4A & 5A) and
14 west Right-Of-Way (ROW) of Telge Road;

15 Then south along west ROW of Telge Road and east boundary of 111
16 tract (ABST 377W HURD TRS 3C 3D 4A & 5A) to southeast corner of said
17 tract;

18 Then generally west northwest along south boundary of said 111 acre
19 tract to southwest corner of said tract;

20 Then north along west boundary of said 111 tract, and 4 acre tract
21 (ABST 377 W HURD TR 4) to northwest corner of said 4 acre tract and
22 south ROW of FM 2920 Rd.;

23 Then east along north boundary of said 4 acre tract and south ROW of
24 FM 2920 Rd. to northeast corner of said tract;

25 Then south along east boundary of said 4 acre tract to southeast
26 corner of said tract and north boundary of 111 acre tract (ABST 377
27 W HURD TRS 3C 3D 4A & 5A);

1 Then east along north boundary of said 111 acre tract to northeast
2 corner of said tract, west ROW of Telge Road and point of beginning
3 of +/-117 acre tract 1;

4 Tract 2 (Decker Prairie-Rosehill) is +/- 99 acres in size, within
5 the J. H. Edwards Survey (Abstract No. 20) and situated east
6 southeast of the intersection of Decker Prairie-Rosehill and Nutty
7 Farms Roads in northwest Harris County with point of beginning
8 being southwest corner of +/- 99 tract (ABST 20 J H EDWARDS TRS 9 &
9 10) and east Right-Of-Way (ROW) of Decker Prairie-Rosehill Rd.;

10 Then north along east ROW of Decker Prairie-Rosehill Rd. and west
11 boundary of said 99 acre tract to west northwest corner of said
12 tract and southwest corner of 50 acre tract (ABST 20 J H EDWARDS TR
13 4);

14 Then east along north boundary of said 99 acre tract, south boundary
15 of said 50 acre tract to interior corner of said 99 acre tract and
16 southeast corner of said 50 acre tract;

17 Then north along boundary of said 99 tract, and east boundary of
18 said 50 acre tract to north corner of said 99 acre tract and
19 southwest corner of 4.4 acre tract (HOLLY CREEK SEC 2 U/R TR 2A-L);

20 Then east along north boundary of said 99 acre tract, and south
21 boundary of HOLLY CREEK SEC 2 U/R TRACTS 2A-L, 2AK-2, 2AK-1, 2AJ,
22 2AA & 2J and 2H to northeast corner of said 99 acre tract;

23 Then south along east boundary of said 99 acre tract, and west
24 boundary of HOLLY CREEK U/R TRACTS P, H, PT TR C1 (HOMESITE), C2 and
25 C3 to southeast corner of said 99 acre tract;

26 Then west along south boundary of said 99 acre tract, and north
27 boundary of ESTATES OF HOLLY LAKE and ABST 20 J H EDWARDS PT TR 8B-2B

1 (AG-USE), TR 8B-2, TR 8F and TR 8B-2D to southwest corner of said 99
2 acre tract, east ROW of Decker Prairie-Rosehill Road and point of
3 beginning of +/-99 acre tract 2;

4 MONTGOMERY COUNTY:

5 Tract 3 (Colony at Pinehurst) being a 123.100 acres partially out of
6 (1) a called 15.511 acre tract described in deed recorded under
7 County Clerk's File No. 8405898, of the Montgomery County Real
8 Property Records (M.C.R.P.R.), (2) called 50.04 acre tract

5 being the beginning of a curve to the left;

6 4) THENCE, SOUTHEASTERLY, 60.46 feet along the southwesterly
7 line of said 0.3088 acre tract and the southwesterly line of
8 Proposed S.H. 249, being along the arc of said curve to the left,
9 having a radius of 5780.00 feet, a central angle of 00°35'58". and a
10 chord bearing SOUTH 59°37'40" EAST, 60.46 feet to the most easterly

22 subdivisions to the creation of districts with conservation,
23 reclamation, and road powers and the inclusion of land in those
24 districts has been complied with.

25 (e) All requirements of the constitution and laws of this
26 state and the rules and procedures of the legislature with respect
27 to the notice, introduction, and passage of this Act have been

1 fulfilled and accomplished.

2 SECTION 5. This Act takes effect immediately if it receives
3 a vote of two-thirds of all the members elected to each house, as
4 provided by Section 39, Article III, Texas Constitution. If this
5 Act does not receive the vote necessary for immediate effect, this
6 Act takes effect September 1, 2015.
